# Cooking gas price hiked by ₹50; commercial LPG dearer by ₹350

The price rise comes days after polling concluded in three northeastern states

NEW DELHI: State-run suppliers have raised the prices of domestic cooking gas by ₹50 per cylinder for 3l3.7 million customers across the country from Wednesday, ahead of Holi and days after polling concluded in three northeastern states, inviting sharp criticism from the Opposition.

This is the first price hike for domestic liquefied petroleum gas (LPG) in about eight months. The three public sector firms, Indian Oil Corporation (IOC), Hindustan Petroleum Corporation Ltd (HPCL) and Bharat Petroleum Corporation Ltd (BPCL), last revised their rates on July 6, 2022.

Before the latest price revision, a 14.2kg gas cylinder costed ₹1,053 in Delhi, ₹1,052.50 in Mumbai, ₹1,068.50 in Chennai and ₹1,079.00 in Kolkata.

to IOC. The prices vary across the country due to different local levies. Though India's cooking gas market is dominated by the three state-run energy firms – IOC, BPCL and HPCL – it is the IOC rates that are treated as the industry benchmark.

The companies also raised commercial LPG rates by ₹350.50 per 19-kg cylinder, which will now cost ₹2,119.50 per refill in Delhi. This is also the first rate hike of the commercial gas cylinder since July 6, 2022 when it was sold at ₹2,012.50 in the national capital. Since then, its rate was gradually reduced

over time. By November 1, 2022, it became cheaper by ₹268.50. While there was no price hike in December, on January 1, the price increased by ₹25 a litre. Commercial cylinders are used in hotels, restaurants, and for industrial applications.

The Opposition criticised the government for the hikes, particularly the one in domestic LPG with the festival of Holi just days away (March 8). In a tweet on Wednesday, Congress president Mallikarjun Kharge said that this would affect the common man who is already facing high inflation. Congress party mem-

bers also staged walkout from the MP Assembly on the issue.

"Increase the price of domestic cooking gas cylinder by ₹50; commercial gas cylinder ₹350 expensive; The public is asking, now how to make Holi dishes; How long will these orders of loot continue? Every person grinds under the back-breaking inflation implemented by Modi government!" Kharge said.

The CPI(M) demanded a rollback in the price hike, saying the burden on people will increase at a time when the cost of all food and essential commodities is rising relentlessly. The BJP did not comment on the matter.

The latest revision is likely to add to the problem of growing inflation. Consumer Price Index (CPI) stood at 6.5% in the month of January after staying below the critical 6% threshold in November and December. Private analysts believe that February inflation print is also likely to stay above the 6% mark. LPG has a weight of 1.2% in the overall inflation basket and inflation in this subcategory stood at 16.2% in January 2023.

In May 2022, the government announced a targeted subsidy of ₹200 per cooking gas (14.2kg) cylinder for 90 million Pradhan Mantri Ujjwala Yojana (PMUY) beneficiaries for up to 12 refills for 2022-23. The move was part of a slew of measures at the time to provide relief to the people from rising inflation. It also included slashing of central duties on petrol by ₹8 a litre and diesel by ₹6 per litre.

LPG is the key fuel for Indian households. According to official data, there are 313.7 crore domestic LPG consumers across the country, covering 105.4% of estimated households based on Census 2011. The LPG coverage is calculated by State-run firms based on the active LPG domestic connections and the estimated number of households.



## Cooking gas, commercial LPG to cost more, jet fuel less

il marketing companies (OMCs) on Wednesday raised prices of both domestic and commercial LPG cylinders, while that of jet fuel received a cut in a move that could help lower air fares.

The price of non-subsidized 14.2-kg domestic LPG cylinder has been increased by ₹50 to ₹1,103 in the national capital, showed data on the Indian Oil Corp site. The price of the 19-kg commercial LPG cylinder witnessed a steep hike of ₹350.50

to ₹2,II9.50 per cylinder.

The hike in domestic cooking gas prices comes after a gap of around seven months post the last revision in July 2022. The price of commercial LPG cylinders which is largely used in restaurant and hotels has been raised twice this year.

With the latest revision, effective I March, a 14.2-kg domestic LPG cylinder is priced at ₹1,102.50 in Mumbai, ₹1,129 in Kolkata, and ₹1,118.50 in Chennai.

LPG prices are key elements of a household budget, and an increase in prices may lead to an increase in inflation rate. The country is already under

inflationary pressure and the retail inflation is above the 6% upper tolerance limit set by the Reserve Bank of India. The Consumer Price Index (CPI) or retail inflation for January rose to a three-month high at 6.52%, according to data from the Ministry of Statistics & Programme Implementation (MoSPI).

Global energy prices had

surged in the aftermath of Russia's invasion of Ukraine last year. Although, global prices have largely remained elevated, they have eased from multi-year highs.

Amid the rise in global oil and gas prices in the past one year, OMCs have not increased the retail price of domestic cooking gas commensurate with the trend in international prices, leading to heavy losses being incurred by OMCs on the sale of these fuels as they were selling below global prices. In October, the Centre gave a one-time special grant of ₹22,000 crore to the three companies to compensate them for their

losses on domestic LPG sales.

However, the OMCs have cut the price of aviation turbine fuel (ATF) by 4%, amid the recent easing of global oil prices owing to a gloomy economic outlook. ATF prices are typically revised on the first of every month based on the average rate of international benchmark and foreign exchange rates. Post the price cut, ATF is priced at ₹1.07 lakh per kilolitre in Delhi, falling from ₹ 1.12 lakh per kilolitre. With the latest cut in jet fuel prices, consumers may witness some relief in air fares as fuel prices account for about 40% of the operating cost of an airline.



#### Domestic LPG cylinder price hiked by ₹50; Opposition seeks rollback

HYDERABAD/NEW DELHI

Cooking gas turned dearer on Wednesday, with the state-owned oil marketing corporations increasing the price of the domestic 14.2-kg cylinder of lique-fied petroleum gas by ₹50 each. The price of the commercial 19-kg LPG refill will now go up by more than ₹350.

The price of the domestic cylinder for households has consequently has shot up to ₹1,103 in Delhi; ₹1,102.50 in Mumbai; ₹1,118.50 in Chennai; and ₹1,129 in Kolkata.

Opposition parties have slammed the hike, and demanded a rollback. The move by Indian Oil, BPCL and HPCL comes amid mounting fears over rising prices across the board, with home and car loans becoming expensive and growing uncertainties about job security, especially in the technology sector. The hike follows close on the heels of the end of polling in a couple of northeastern States and just ahead of Holi.

The three oil marketing corporations, commanding a lion's share of the LPG market, had previously increased domestic LPG prices by an identical ₹50 a refill in July 2022. Barring those issued LPG connec tions under the Ujjwala scheme for economically weaker families, most households are either ineligible for or have given up subsidy, and thus face the heat when prices are hiked.

## Domestic LPG cylinder price hiked by ₹50

Though the oil corporations are technically empowered to revise LPG prices every month, they tend to use this power more for commercial cylinders or the bigger refills used by establishments from tea stalls to restaurants. Following the latest revision, a 19-kg LPG cylinder costs ₹2,119.50 in Delhi; ₹2,071.50 in Mumbai; ₹2,268 in Chennai; and ₹2,221.50 in Kolkata.

The Congress and the CPI(M) hit out at the Narendra Modi-led government over the LPG price hikes, demanding an immediate rollback.

Addressing a press conference at Congress headquarters in Delhi, party spokesperson Gourav Vallabh said the Union government could take lessons from Congress-ruled Rajasthan on how to keep cooking gas price below ₹500.

In the nine years of the BJP regime, Mr. Vallabh said the Union government had only paid a subsidy bill of ₹36,500 crore for LPG cylinders, while the Congress-led UPA government had paid ₹2.14 lakh crore in subsidies between 2004 and 2014.

"The loot does not end here. The Modi government imposed 5% GST over LPG cylinders and 18% for commercial gas. The reason for the dismal 4.4% GDP growth in the third quarter is that manufacturing is having a negative growth, a contraction of -1.1%, and the private consumption is not picking up," he alleged, adding that this could not be the economic governance model of any democratic government.

#### 'Common man's burden'

The CPI(M) Polit Bureau also strongly condemned the hike, saying that it further increased the burden on people who are already suffering due to an increase in the prices of food and essential commodities.

"With this hike, more people will drop out from using subsidised cooking gas cylinders as they simply cannot afford it. Already, over 10% of those under Ujjwala Yojana have not taken any refill cylinders during last year. Nearly 12% took only 1 refill. A total of 56.5% took only 4 or less refills against the minimum required annual average of 7+ cylinders, and against an entitlement of 12 cylinders per year," the Polit Bureau statement said.

The party further pointed out that the price of commercial LPG cylinders have been increased for the second time this year.

Cooking gas LPG (liquefied petroleum gas) price on Wednesday was hiked by Rs50 per cylinder. Parallely, oil firms also hiked the price of commercial LPG, used in hotels and restaurants, by Rs350.5 per cylinder.

In an indirect reference to Union home minister Amit Shah's speech in Parliament in 2018 wherein he had said "better to sell pakodas than be jobless", Alemao said, "A commercial LPG cylinder will cost Rs2,118 with a hike of Rs350 per cylinder. Now, even frying pakodas will be difficult for educated unemployed youths."

He said a domestic LPG cylinder will now cost Rs1,117 with the latest price hike.

#### MP govt presents ₹3.14lakh-cr budget; Congress walks out against cylinder hike

**Bhopal:** The Madhya Pradesh government on Wednesday presented a Rs3.14 lakh crore Budget for 2023-24 with a provision of Rs 8,000 crore for Mukhkyamantri Ladli Behna Yojna, a new scheme to be rolled out for the welfare women in the state where the assembly poll is due this year-end.

# High demand keeps Feb fuel sales on fast track

# Onset Of Summer, Agri Needs Boost Petrol Consumption 13%, Diesel 12%, Jet Fuel 41%

New Delhi: Petrol, diesel and jet fuel sales continued to gallop in February, prompted by the early onset of summer, farm sector demand, and increased mobility due to expanding economic activities.

Early trade data shows petrol consumption rising 13%, diesel 12% and jet fuel almost 41% over the same month a year ago. Consumption of LPG, mostly used by households for cooking, maintained the usual modest growth of 2.4%.

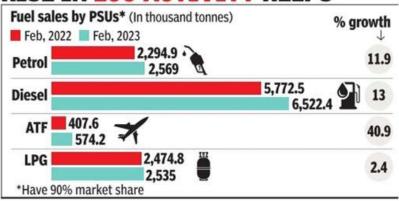
The growth in consumption was substantially higher than in the same month of 2021 when the economy began firing up after the pandemic. Compared to February 2021, petrol, diesel and jet fuel sales were way higher by 15.7%, 12.1% and 41.3%, respectively.

The growth in diesel sales, however, appeared modest at 7.7% compared to February 2020, when the pandemic was yet to squeeze demand. Since diesel is a key indicator of economic activities, this indicates a lingering pandemic overhang.

In contrast, petrol sales show a sharp uptick at 20% tance. Industry is banking on the summer travel season for full recovery.

Sequentially also, the sales in February were higher by 13.5% for petrol, 9.2% for diesel and just 3.3% for jet fu-

versus February 2020 as people's preference for personal vehicles during the post-pandemic unlock period continues, as reflected in robust automobile sales.

Similarly, jet fuel sales have gradually recovered but still remains nearly 10% short of the February 2020 level, indicating some resisel, the data shows. The early onset of summer and absence of winter rains have pushed up demand from the farm sector, shown by increased use of diesel pumps for irrigating late standing crops such as mustard. Harvesting in states that have early harvesting further boosted the demand.



## India's fuel sales surge in Feb after winter lull

**NEW DELHI:** India's fuel demand witnessed the sharpest rebound in February as petrol and diesel consumption rose by double digits after a winter lull in the previous month, preliminary industry data showed on Wednesday.

Petrol sales of state-owned fuel retailers jumped 12 per cent to 2.57 million tonne in February, as compared to 2.29 million tonne of consumption in the same period of last year. Sales were 1.57 per cent higher than in COVID-marred February 2021 and 20 per cent more than in the same period of 2020. Month-onmonth, the demand was up 13.5

per cent, reversing the dip in the previous month. Sales had fallen 5.1 per cent month-on-month in January as cold conditions cut vehicular movement.

Diesel, the most used fuel in the country, posted a 13 per cent rise in sales during February to 6.52 million tonne, as compared to the same period last year.

Consumption was 12.1 per cent higher than February 2021 and 7.7 per cent more than the same month of 2020. Monthon-month sales surged 9.2 per cent from 5.97 million tonne in January. In January, diesel consumption fell 8.6 per cent month-on-month as snowfall

in higher reaches halted truck movement.

Industry sources said diesel demand surged as trucks returned to roads and rabi sowing season peaked. Use of the fuel in irrigation pumps and trucking helped build the momentum. January sales were lower month-on-month also because the previous month had seen a surge in consumption due to vacation travel. With the continued opening of the aviation sector, India's overall passenger traffic at airports inched closer to pre-Covid levels.

Reflecting the trend, jet fuel (ATF) demand jumped 41 per

cent to 574,200 tonne in February when compared to the same period last year. It was 41.3 per cent higher than February 2021 but 9.7 per cent lower than February 2020. Month-on-month sales were up 3.3 per cent.

LPG sales were up 2.43 per cent year-on-year at 2.53 million tonne in February. LPG consumption was 12 per cent higher than in February 2021 and 22.2 per cent more than in February 2020. Month-onmonth, the demand was up 6.14 per cent when compared to 2.38 million tonne of LPG consumption during January, the data showed.

#### NSE gets Sebi nod to launch WTI crude oil, natural gas futures contracts

NEW DELHI: India's top oil and gas producer Oil and Natural Gas Corporation (ONGC) now has a director for production after two directorships were merged as part of a larger board revamp aimed at breathing fresh life into the state-owned behemoth.

The post of Director (Production) has been created after merging Director (Onshore), who is in charge of all oil and gas fields located on land, and Director (Offshore) who looks after all offshore assets such as the prime Mumbai High fields.

Pankaj Kumar, Director (Offshore), will be the first Director (Production), ONGC said in a stock exchange filing.

Aiding the merger of the two posts was the retirement of Director (Onshore) Anurag Sharma on February 28.

ONGC in the filing said Ministry of Petroleum and Natural Gas has through a letter dated February 28 "conveyed continuance of Pankaj Kumar, Director (offshore), in the newly created post of Director (Production), a post created after merger of the posts of Director (Onshore) and Director (Offshore), with effect from March 1,2023 till the date of his superannuation i.e. June 30, 2026 or until further orders, whichever is earlier."

Prior to this, the ONGC board had six directors for exploration, onshore operations, offshore operations, finance, human resources and technical and field services. It used to be headed by a chairman and managing director.

The government in December last year appointed Arun Kumar Singh, who had retired as head of oil refining and fuel marketing company BPCL, as the chairman of ONGC but not as its managing director. MPOST

# Petrol Sales Up 12%, Diesel 13% on Higher Mobility

New Delhi: Domestic sales of petrol and diesel rose 12% and 13% respectively in February over the same month last year on account of increased mobility of people and goods in an expanding economy.

Petrol and diesel sales in February were 20% and 8% higher respectively than in the same month of 2020 ahead of the Covid lockdowns, according to the preliminary sales data from staterun oil companies. The lockdowns, which began in March 2020, disrupted mobility and sharply cut fuel demand. Jet fuel sales in February were 41% higher than in the same month last year but 10% lower than in 2020, showing how the aviation industry still needed some time to reach the pre-pandemic level.

Sales of liquefied petroleum gas (LPG), mainly used for cooking in the country, are up 2.4% from the previous year and 22% higher than in February 2020. Cooking gas demand remained steady through the pandemic while the sales of petrol, diesel and jet fuel fell sharply.

Petrol quickly recovered as lockdowns eased and people started to re-

#### SALES PICK UP

Consumption was 12.1 per cent higher than February 2021 and 7.7 per cent more than the same month of 2020.

Month-on-month sales surged 9.2 per cent from 5.97 mt in January.

In January, diesel consumption fell 8.6 per cent month-on-month as snowfall in higher reaches halted truck movement.

Industry sources said diesel demand surged as trucks returned to roads and rabi sowing season peaked. Use of the fuel in irrigation pumps and trucking helped build the momentum.

January sales were lower month-on-month also because the previous month had seen a surge in consumption due to vacation travel.

If there is a good strategic fit for us, we would look at that as an opportunity for us to buy into the company or acquire the company in totality," Purohit said. solutions from 2023 to 2026.

Petronas planned capital expenditure of 60 billion ringgit last year.

Malaysia still require polices and incentives that encourage private investments in the sectors, Purohit said, adding that the firm intends to invest strongly in the Southeast Asian nation. Last month, Gentari purchased Australian renewables firm Wirsol Energy, which has solar and battery energy storage systems.

# Rising prices of natural gas hit consumption in 2022, says IEA

**COST FACTOR.** LNG imports dropped by 17 per cent during the year, the steepest fall on record

The consumption of natural gas in India, the world's third largest energy consumer, fell by 6 per cent y-o-y in 2022 calendar year as high prices weakened demand, the International Energy Agency (IEA) said.

India consumed 60,523 million standard cubic meters of natural gas in the last calendar year against 64,658 mscm in 2021, data from Petroleum Planning and Analysis Cell (PPAC) show.

The decline in consumption, particularly across power, refining and petrochemicals, has largely been on account of high prices of natural gas in international markets as Europe se-

cured supplies for the winters at record high prices (average in 2022 at \$34 per mBtu) following the Russia-Ukraine war, which began in February last year.

"India's gas consumption is estimated to have declined by 6 per cent in 2022 as high prices squeezed gas demand for power generation (down 24 per cent y-o-y), refining (down 30 per cent y-o-y) and petrochemicals sector (down 32 per centyo-y in particular," IEA said in its gas market report for Q1 2023.

#### CGD DEMAND FLAT

City gas demand was broadly flat, while consumption in the

fertiliser segment and other end uses (which include agriculture, upstream operations and other industries) saw modest expansion throughout 2022, although they were not enough to compensate for the steep declines in the more price-sensitive sectors of the economy, it added.

In Asia, LNG spot prices averaged at \$34 per mBtu in 2022, which is more than five times the five-year average between 2016 and 2020.

"In 2023, total gas consumption is expected to increase by 4 per cent, thanks to a modest recovery in power sector gas use and continuing – albeit slow – growth in the industrial and city gas sectors," the global agency tracking the energy sector has projected.

Price-driven fuel-switching

played the leading role in suppressing LNG demand, but a modest 3 per cent increase in domestic production also contributed to the decrease in LNG inflows, IEA said.

#### **GAS PRODUCTION**

As per PPAC, India's gas production, which accounts for half of the country's demand, stood at 33,362 mscm in 2022 compared to 32,362 mscm in 2021.

India's LNG imports dropped by 17 per cent in 2022, the steepest fall on record and the first decline covering two consecutive years in India's two-decade history as an LNG importer, the IEA report revealed.

India imported 27,161 mscm of LNG in 2022 against 32,655 mscm in 2021.

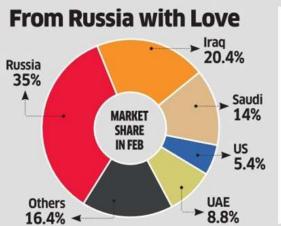
## Russian Crude Imports in Feb up 28% Over Jan

New Delhi: India imported a record 1.6 million barrels per day of crude oil from Russia in February, which made up 35% of its total import and was more than the combined share of Iraq and Saudi Arabia, the second and third-largest suppliers, according to energy cargo tracker Vortexa.

The imports from Russia surged 28% over the previous month as an embargo on Russian crude by the European Union made more supplies available to the Indian refiners and the G-7 price cap didn't quite obstruct trade. Historically a minor user of Russian oil due to costly logistics, India imported less than 1% of its crude from Russia in 2021 and no oil at all in February last year.

"The strong uptick is a clear sign that Russian crude is well-received by Indian refiners in lieu of its attractive price." said Serena

The surge in Russian supplies has hit Iraq and Saudi Arabia, whose combined share in Indian imports has fallen to 34% from 43% in February 2022, when the Russian invasion of Ukraine began, triggering a massive reshuffle of the global oil trade. The shares of Africa and the US in the Indian market have also dropped.

India's import of refined products from Russia has also risen. Import of naphtha rose 15 times from 3,800 barrels per day in January to 57,000 barrels per day in February. Imports of Russian fuel oil, however, fell a quarter in a month to 123,000 barrels per day in February. "Imports of Russian fuel oil have fallen as a result of more supplies diverted to Saudi Arabia and

China last month," Huang said.

The price cap hasn't dented imports but made it harder for Indian refiners such as HPCL, BPCL and Indian Oil to pay for Russian oil, according to people familiar with the matter. The western banks are seeking trade details to ensure payments are being made only for Russian oil purchased below the cap. Since all dollar trans-

actions are settled in the US, Indian refiners are switching to UA-E's dirham and Russian roubles to pay for cargoes bought at prices above the cap, they said.

"India's continued import of Russian crude is predicated on having financial and logistical services to support the trade, for sure," Huang said. "Given the favourable economics that Russian crude offers, I believe the Indian government will work with HPCL and any other public sector refiners facing payment challenges to resolve the issue."

The G-7 countries imposed a price cap on crude in December and on refined products in February. Any deal struck above the cap cannot be supported by the financiers, insurers and shippers based in G-7 countries. Russia exports multiple grades of crude but its flagship Urals, which comprises about 80% of India's Russian imports, has been trading below the cap of \$60 per barrel. This has made the cap redundant for most trades.

## नियामकों के पद खाली रहने से नीतिगत फैसलों पर पड़ रहा है असर

सरकार ने 4 माह में दूसरी बार पिछले सप्ताह भारतीय प्रतिस्पर्धा आयोग के नए चेयरमैन के पद के लिए आवेदन मांगा है। यह पद पिछले साल 25 अक्टूबर को अशोक कुमार गुप्त के सेवानिवृत्त होने के बाद से खाली पड़ा है।

प्रतिस्पर्धा आयोग एकमात्र नियामक नहीं है, जहां चेयरमैन की तलाश हो रही है।

पेट्रोलियम और प्राकृतिक गैस नियामक बोर्ड (पीएनजीआरबी) पिछले 2 साल से बगैर चेयरमैन के काम कर रहा है। इस पद के लिए दो बार विज्ञापन जारी किया जा चुका है और आखिरी बार पिछले साल जून में जारी किया गया था। पीएनजीआरबी के चेयरमैन का पद 4 दिसंबर, 2020 से खाली पड़ा है, जब दिनेश के श्राफ ने 3 साल कार्यकाल पूरा किया था। सरकार चयन प्रक्रिया चला रही है, लेकिन अब तक कोई

पीएनजीआरबी बोर्ड में चेयरमैन के अलावा 4 सदस्य होते हैं। इसमें भी पद नहीं भरे हैं। पीएफआरडीए में भी यही कहानी है, जिसके बोर्ड में पद रिक्त हैं। वहीं सीसीआई के 2 सदस्य जल्द सेवानिवृत्त होने वाले हैं, जिसके लिए पहले ही विज्ञापन जारी हो गया है।
