

il giant Saudi Aramco reported Sunday earning \$161 billion last year, claiming the highest-ever recorded annual profit by a publicly listed company and drawing immediate criticism from activists.

The monster profit by the firm, known formally as the Saudi Arabian Oil Co., came off the back of energy prices rising after Russia launched its war on Ukraine in February 2022, with sanctions limiting the sale of Moscow's oil and natural gas in Western markets.

Aramco also hopes to increase its production to take advantage of market demand as China reenters the global market after lifting its coronavirus restrictions. That could raise the billions needed to pay for Crown Prince Mohammed bin Salman's plans to develop futuristic cityscapes to pivot Saudi Arabia away from oil.

However, those plans come despite growing international concerns over the burning of fossil fuels accelerating climate change. Meanwhile, higher energy prices already have strained relations between Riyadh and Washington, aswell as driven up inflation worldwide.

"Given that we anticipate oil and gas will remain essential for the fore-seeable future, the risks of underinvestment in our industry are real—including contributing to higher energy prices," Saudi Aramco CEO and President Amin H Nasser said in a statement.

Profits rose 46.5% when compared to the company's 2021 results of \$110 billion. It earned \$49 billion in 2020 when the world faced the worst of the

coronavirus pandemic lockdown, travel disruptions and oil prices briefly going negative.

Aramco putits crude production at around 11.5 million barrels a day in 2022 and said it hoped to reach 13 million barrels a day by 2027.

To boost that production, it plans to spend as much as \$55 billion this year on capital projects.

Aramco also declared a dividend of \$19.5 billion for the fourth quarter of 2022, to be paid in the first quarter of this year.

Aramco's results, viewed as a bellwether for the global energy market, mirror the huge profits seen at those of UK energy giant BP, America's Exxon Mobil, Shell and others in 2022. But the sheer size of the SIGI billion profit overshadowed even its own previous results, as well as records by Apple, Vodafone and the U.S. Federal National Mortgage Association, or Fannie Mae.

Benchmark Brent crude oil now trades around \$82 a barrel, though prices hadreached over \$120 a barrel back in June. Aramco, whose fortunes hinge on global energy prices, announced a record \$42.4 billion profit in the third quarter of 2022 off the back of that price spike.

Those high prices have further strained ties between the kingdom and the United States, traditionally a security guarantor among the Gulf Arab states amid tensions with Iran. Before the midterm elections in November, the kingdom said the

Biden administration sought to delay a decision by OPEC and allies including Russia to cut production that could have kept gasoline prices lower for voters — making public the typically behind-the-scenes negotiations common in the region.

President Joe Biden had warned the kingdom that "there's going to be some consequences for what they've done" in terms of oil prices.

However, those consequences have yet to be seen as Saudi Arabia and Iranwent to China to strike a diplomatic deal Friday. US gasoline prices now stand on average at \$3.47 a gallon, down just about a dollar from lest teers.

For the kingdom, higher crude oil prices can help fuel the dreams of

Prince Mohammed, including his planned \$500 billion futuristic desert city project called Neom.

Those revenues also can go into Riyadh Air, a new airline announced Sunday by Prince Mohammed that will be under the kingdom's Public Investment Fund and plans to fly to over 100 destinations by 2030. The Wall Street Journal, citing anonymous sources, reported Saudi Arabia may purchase up to \$35 billion worth of planes from Boeing Co.

However, they also run against the fears of activists over climate change, particularly as the United Nations' COP28 climate talks will begin this November in the neighboring United Arab Emirates.

Saudi Arabia has pledged to have net-zero carbon emissions by 2060, like China and Russia, though its plans to reach that goal remain unclear. Aramco's earnings report noted itstarted a \$1.5 billion Sustainability Fund in October and plans a carbon-capture-and-storage facility

Amnesty International's secretarygeneral, Agnès Callamard, criticized Aramco's annual profit coming amid global concerns about climate change.

"It is shocking for a company to make a profit of more than \$161 billion in a single year through the sale of fossil fuel — the single largest driver of the climate crisis," she said in a statement. "It is all the more shocking because this surplus was amassed during a global cost-of-living crisis and aided by the increase in energy prices resulting from Russia's war of aggression against Ukraine."

Callamard also noted that Saudi Arabia remains one of the world'stop executioners while also remaining locked in a yearslong war in Yemen and cracking down on dissent.



AS THE European Union (EU) weans itself off refined petroleum products from Russia, Indian refiners, particularly private sector companies, are rushing in to fill the gap, making the region the top destination for India's refined product exports, government data shows.

This comes as Indian refiners snap up discounted Russian crude oil shunned by the EU and other Western powers, with analysts pointing to a clear possibility of products refined from Russian barrels reaching the EU's markets via India.

In the run-up to the EU's ban on Russian petroleum products from February 5 — owing to the Ukraine invasion — India saw its refined product exports to the region rise for five straight months, data from the Directorate General of Commercial Intelligence and Statistics (DGCIS) shows.



तेल कंपनी सउदी अरामको ने 2022 में 161 अरब डॉलर का रिकॉर्ड लाभ कमाया

दुबई, एपी। तेल कंपनी सऊदी अरामको ने 2022 में 161 अरब डॉलर का लाभ अर्जित किया है, जो किसी भी सार्वजनिक क्षेत्र की सूचीबद्ध कंपनी द्वारा अर्जित किया गया सर्वाधिक लाभ है। कंपनी ने रविवार को यह जानकारी दी। कंपनी का मुनाफा 2022 में रूस-यूक्रेन युद्ध शुरू होने के बाद ऊर्जा की कीमतों में वृद्धि के कारण रिकॉर्ड स्तर पर पहुंच गया। सऊदी अरामको के मुख्य कार्यपालक अधिकारी (सीईओ) और अध्यक्ष अमीन एच नसीर ने एक बयान में कहा, "हमें उम्मीद है कि निकट भविष्य में तेल और गेस की मांग बनी रहेगी।" कंपनी ने 2021 में 110 अरब डॉलर का लाभ अर्जित किया था। इस तरह 2022 में उसका लाभ 46.5 प्रतिशत बढ़ा। कंपनी ने 2020 में कोविड महामारी के कारण लॉकडाउन के बीच 49 अरब डॉलर का लाभ अर्जित किया था। अरामको ने 2022 में प्रतिदिन 115 लाख बेरल कच्चे तेल का उत्पादन किया। कंपनी ने 2027 तक इसके प्रतिदिन 130 लाख बेरल तक पहुंचने की उम्मीद जताई है। उत्पादन बढ़ाने के लिए कंपनी इस साल प्रमुख परियोजनाओं में लगभग 55 अरब डॉलर खर्च करने की योजना बना रही है।





सीमा पार तेल पाइपलाइन की 18 मार्च को शुरुआत

शुभायन चक्रवर्ती नई दिल्ली, 12 मार्च

भारत की पहली सीमा पार तेल पाइपलाइन शुरू होने वाली है। बांग्लादेश की प्रधाममंत्री शेख हसीना और भारत के प्रधानमंत्री नरेंद्र मोदी 18 मार्च को वीडियो कॉन्फ्रेंस के माध्यम से पाइपलाइन की शुरुआत करेंगे। बांग्लादेश के विदेश मंत्री एके मोमेन ने शुक्रवार को यह जानकारी दी। 130 किलोमीटर लंबी भारत-बांग्लादेश मित्रता पाइपलाइन (आईबीएफएल) दोनों देशों के कुछ द्विपक्षीय कदमों का हिस्सा है, जिसके तहत बांग्लादेश ऊर्जा की बढ़ती घरेलू मांग पूरी कर सकेगा। इससे असम के नुमालीगढ़ रिफाइनरी लिमिटेड से हाईस्पीड डीजल की ढ़लाई होगी। इस पाइपलाइन से एनआरएल के पश्चिम बंगाल के सिलीगुड़ी स्थित मार्केटिंग टर्मिनल से बांग्लादेश की सरकारी कंपनी बांग्लादेश पेट्रोलियम कॉर्पोरेशन (बीपीसी) के तेल डिपो तक तेल ले जाया जाएगा, जो पड़ोसी देश के दिनाजपुर जिले के प्रभातीपुर शहर में स्थित है। इसका कस्टडी ट्रांसफर प्वाइंट बांग्लाबंधा इंटरनैशनल बॉर्डर होगा, जो सिलीगुड़ी के उपनगरीय इलाके में है। बीपीसी को बांग्लादेश के भीतर विपणन का संपूर्ण अधिकार होगा। आईबीएफपीएल का शिलान्यास सितंबर 2018 को हुआ था। इस परियोजना की निगरानी दोनों देशों के प्रधानमंत्री कार्यालय कर रहे हैं।

इस पाइपलाइन पर 377.08 करोड़ रुपये खर्च आया है। द्विपक्षीय परियोजना का वित्तपोषण भारत के 285.24 करोड रुपये अनदान और एनआरएल के 91.84 करोड रुपये से हुआ है। इसमें सिर्फ 5 किलोमीटर पाइपलाइन भारतीय क्षेत्र में बनी है, जबकि शेष बांग्लादेश से होकर गुजरती है। इस पाइपलाइन से 10 लाख टन सालाना तेल की ढुलाई की जा सकती है। इस उपमहाद्वीप के अन्य देशों की ही तरह बांग्लादेश के आयात में भी रिफाइंड पेट्रोलियम के आयात पर कुल लागत का बड़ा हिस्सा जाता है। ऑब्जवेटरी आफ इकनॉमिक कॉम्प्लेक्सिटी (ओईसी) के मुताबिक 2020 में बांग्लादेश रिफाइंड पेट्रोलियम का विश्व का 42वां बड़ा आयातक था, जिसने 2.64 अरब डॉलर पेट्रोलियम का आयात किया। इस साल सिंगापुर, चीन, भारत, मलेशिया और थाईलैंड उसके बड़े स्रोत थे।

इस परियोजना के सफलतापूर्वक शुरू होने से इस तरह के अन्य द्विपक्षीय संबंधों को भी बल मिलने की संभावना है। भारत विभिन्न परियोजनाओं के लिए बांग्लादेश को अनुदान दे रहा है, जिसमें अखौरा-अगरतला रेल लिंक का निर्माण, बांग्लादेश में जलमार्गों की खुदाई शामिल है।

एनआरएल और बीपीसी ने अप्रैल 2017 में हाई स्पीड डीजल की बिक्री को लेकर दीर्घावधि समझौता किया था जो आईबीएफएल के माध्यम से भारत से बांग्लादेश भेजा जाना है। उसी साल अक्टूबर में सरकारी कंपनी एनआरएल ने बीपीसी के साथ एक और 15 साल का समझौता किया, जो पड़ोसी देश को डीजल के निर्यात के लिए था।
