

MGL to Expand into CBG, LNG & EV Segments

Mumbai: In a bid to diversify its portfolio, state-run city gas distributor (CGD) Mahanagar Gas Ltd (MGL) is planning to expand into business areas other than city gad distribution (CGD), a senior executive said.

The company is planning to enter the compressed biogas (CBG) segment, the electric vehicles market, equipment manufacturing for CGD companies and retailing LNG as fuel for long-haul transportation.

"We have some cash on our balance sheet and we would like to expand our portfolio in terms of seeing how we can make its best use," said Ashu Shinghal, managing director, MGL. "Our net worth is around ₹4,000 crore. We are a zero-debt company, so we can also take a loan in case required," added Shinghal.

Last month, MGL acquired 100 percent shareholding of Unison Enviro Pvt. Ltd. (UEPL) for ₹531 crore to enter new geographical areas for pursuing inorganic growth opportunities. MGL said Unison Enviro would become a subsidiary and would be rebranded.

New Delhi: India is likely to offer incentives to fleet owners for adoption of CNG, LNG, electric or green hydrogen-powered trucks as part of the proposed green ports policy. The move is aimed at reducing the intensity of emissions at major ports, a senior government official told ET.

India currently has 12 major ports that handle around half of the count-

ry's total cargo movement. Each major port has been asked to establish at least one LNG bunkering station by 2030 and have an adequate number of EV charging stations in port campuses or nearby by 2025.

Major ports come under the administrative control of the shipping ministry, while the remaining ports (called non-major) come under the state governments and their maritime boards.

"Key interventions include prompting use of renewable energy, reducing air emissions, optimising water usage, improving solid waste management and lowering carbon emission per tonne of cargo handled by 30% by 2030, and 70% by 2047," the official quoted above said.

Ports will also be required to increase the green cover to capture the fugitive emissions and attenuate the noise generated in the port surroundings. This will be done by carrying out effective plantations and developing landscapes with a goal to increase green belt by over 20% by 2030 and by 33% by 2047.

They will have to make efforts to achieve the target for electrification of vehicles and ports equipment. Port equipment sea electrification levels need to reach 50% by 2030 and 90% by 2047. It has been stated that green ammonia bunkers and refuelling facilities shall be established at all major ports by 2035.

Amid refinery stir, Maha industries min meets Pawar

Mumbai: A day after local protests flared up against the proposed refinery project in Ratnagiri's Barsu village, industries minister Uday Samant met NCP chief Sharad Pawar and later announced that the district administration would hold a meeting with the villagers to clear misunderstandings about the project.

The meeting comes a day after Pawar spoke to Samant on the phone. "I responded to his queries and assured him that the administration is keen on convincing the villagers," said Samant. Chief minister Eknath Shinde had also spoken to Pawar, he said.

Samant said district authorities in Ratnagiri will hold a meeting with 300-350 villagers on Thursday and make a detailed presentation. "All the villagers are not opposed to the project. There are also those who support the project. We...want to convince the protesters," Samant said.

Samant clarified that only soil testing was underway at the site and the result would determine whether the project would be located there. "No survey is being conducted. Soil testing is underway. Only after that can the company decide if the project can be located there. Things are at a very preliminary stage," he said. He said women who were part of the protest on Tuesday had been accompanied to their homes.

Meanwhile, Pawar said, "In my opinion, before undertaking a major project, the administration must understand the views of the villagers. If they are against the project, then efforts should be made for a via-media."

Pawar said discontentment appears to be brewing among the villagers. The government must take serious note of people's sentiments, NCP chief said.

"If a new formula comes out, it will be a happy situation. If there is no solution, dialogue must be held with the agitating villagers. Take the local villagers into confidence for finding out a solution," Pawar said.

Pawar said the opposition has been pointing out that major industries have been shifting to other states, and that the Konkan region was being neglected.

"Under such circumstances, it is the responsibility of the government to understand the woes of local villagers. Efforts should be made to clear their misunderstandings and if there is a need, an alternate site should be found," Pawar said.

As hundreds of villagers continued their protest for the third day, the Maharashtra Police have banned the entry of several Shiv Sena (UBT) leaders to the proposed giant Ratnagiri Refinery & Petrochemicals Ltd, coming up with Arab help near Barsu, officials said here on Wednesday.

Notices have been served on various Sena (UBT) leaders, including MP Vinayak Raut and the party's district chief Vilas R. Chalke and others, asking them not to proceed to Barsu as a potential law and order situation could arise.

Ignoring the government's pleas Raut and others have decided to travel to Barsu and meet the agitation villagers today. Taking a tough stance, the Ratnagiri Police have extended the prohibitory orders in the RRPL site vicinity till May 31 in view of the drone survey and land drilling works taken up there.

The prohibitory orders are applicable within one km of Barsu, Panhale, Dhopeshwar, Goval, Varchiwadi-Goval,



Khalchiwadi-Goval, and those flouting them shall be penalised, said the Police Inspector Vineet Chaudhary.

The Opposition Maha Vikas Aghadi leaders have urged the ruling Shiv Sena-Bharatiya Janata Party government to exercise restraint, call off the soil survey and testing and allow the villagers their right to protest against the project in the lush coastal belt.

Congress's Nana Patole, Balasaheb Thorat, Atul Londhe, Nationalist Congress Party's Leader of Opposition (Assembly) Ajit Pawar, Jayant Patil, Sena (UBT)'s Leader of Opposition (Council) Ambadas Danve, Aditya Thackeray, Sanjay Raut, Vinayak Raut, Anil Parab, CPI (M) and other parties' leaders have strongly castigated the government for trying to crush the villagers' protests.

However, BJP's Deputy CM Devendra Fadnavis said that irrespective of the protests, there's no going back and "the RRPL project will come up in the state at the proposed location".

Govt sticking to target of 5K CBG plants by '24-25

New Delhi, 26 April

The launch of 200 small-scale compressed biogas (CBG) projects, state-led growth, and higher commercial sale rates, along with a host of separate policy measures, can still boost a key central scheme to push up CBG production in India, the government believes.

Top officials from the Ministry of Petroleum and Natural Gas (MoPNG) recently told industry stakeholders at a meeting in Delhi that it will not scale back the target of setting up 5,000 commercial CBG plants by 2024-25 under the Sustainable Alternative Towards Affordable Transport (SATAT) scheme.

Launched in 2018, SATAT aims at incentivising the production of CBG from various biomass sources. But the scheme has lagged behind targets, with the country only being able to establish 46 CBG plants so far. This may change soon, said officials. Officials told the Global Conference on CBG last week that

Officials expressed hope that a large number of plants are set to go live soon, given that long-term commercial agreement for the procurement of CBG by oil and gas marketing companies.

MoPNG has issued policy guidelines for commingling of CBG with natural gas in city gas distribution (CGD) networks, while the Reserve Bank of India has included CBG projects under priority sector lending, they told *Business Standard*.

"We are working to facilitate the setting up of as many as 200 CBG

projects under the umbrella of the GOBARdhan (Galvanizing Organic Bio-Agro Resources dhan) scheme. An announcement will be made soon," an official said.

Launched in 2018, the GOBARdhan scheme aims at managing and converting cattle dung and solid waste in farms into compost, biogas, and bio-compressed natural gas (CNG).

Also, the Central Pollution Control Board has included CBG plants under its 'white category' status, clubbing them with other industries which are practically non-polluting, the official added. This excuses plants from seeking green clearances.

Commercial CBG procurement prices may also be raised soon, officials hinted. A primary request of the producer industry, minimum procurement prices for the gas were last raised in June 2022 to ₹54 per kilogram.

Slow, not steady

The government is refocusing its approach to the scheme, officials had told Business Standard in October 2022. Subsequently, in December, the parliamentary standing committee on piped natural gas noted that the scheme was "burdened by lack of clarity, procedural hurdles, and has not enthused investors and entrepreneurs to come forward to set up CBG plants".

The committee had also recommended that the petroleum ministry should set up a panel to review the letters of intent (LoIs) issued so far and also issue guidelines for fresh LoIs.

What is equity oil?

EQUITY OILIS the share of oil production that an investor is entitled to receive based on their ownership stake in an oil field. If a company owns a 20% stake in an oil field which produces 100,000 barrels of oil per day, the company is entitled to receive 20,000 barrels of oil per day as its share of production.

It ensures availability and reduces uncertainty. Equity oil helps a country secure a reliable supply and partially protects it from geopolitical risks in terms of oil supply. Energy security is a major concern for India, and investing in oil assets abroad is a strategic move to ensure oil availability and support the country's economic growth. India started investing in oil assets abroad in the 1990s. Some of these earn dividends, while other investments are for equity oil.

Why India needs equity oil

WITH LIMITED DOMESTIC oil reserves and falling production, India is the world's third-largest oil importer, which makes it vulnerable to fluctuations in global oil prices and supply disruptions. Ironically, since 2015, when Prime Minister Narendra Modi exhorted stakeholders to reduce import dependence, domestic crude oil production has fallen by about 19%—from 35.9 million tonne in FY15 to 29.2 million tonne in FY23.

Import dependence, instead offalling from 77% in 2015 to 67% by 2022 as Modi had wished, shot up to 87% in FY23. And, the import bill rose 30% to nearly \$147 billion in FY23. No new oil blocks were awarded in most part of the last decade. State-run ONGC, India's largest oil and gas producer, hasn't made any major recovery after the drying up of Bombay High as higher dividends constrain its cash reserves and capex.

India's equity-oil investments

ONGC VIDESH (OVL), the overseas arm of India's Oil and Natural Gas Corporation (ONGC), has the biggest stakes in foreign oil fields, particularly in Russia, Brazil and Mozambique. OVL has stakes in 33 oil and gas projects in 15 countries Azerbaijan (two projects), Bangladesh (two), Brazil (two), Colombia (five), Iran (one), Iraq (one), Libya (one), Mozambique (one), Myanmar (six), Russia (three), South Sudan (two), Syria (two), UAE (one), Venezuela (two) and Vietnam (two).

The company, as per its website, adopts a balanced portfolio approach and maintains a combination of producing, discovered, exploration and pipeline assets. Other Indian companies like Oil India, BPCL and IOCL have also made investments in a few countries, including Sudan, the UK and Peru. These are both equity and debt investments.

How effective has equity-oil strategy been

THOUGH THE STRATEGY is sound, it is yet to prove beneficial for the Indian oil sector.
Investments in equity oil do secure long-term crude oil supplies for the country and reduce India's dependence on the volatile international oil markets, at least for the amount of oil under agreement in equity

deals. However, considering the country's total requirement, these investments are quite low and are far from having any meaningful stabilising effect on India's energy security.

India's biggest equity-oil investor, OVL, gets six million barrels whereas the yearly requirement is about 235 million tonne. Apart from the investments being small, there are other factors such as geopolitical risks, unstable oil prices, and operational challenges.

At times, India has been elbowed out by the Chinese in acquisition of these assets. A decade ago, India lost to China in Kazakhstan, on the giant Kashagan oil-field—India was looking to buy a 8.4% stake from ConocoPhillips. Generally, these resource-rich hot spots have high geopolitical risks.

India's investments in Sudan and Venezuela have faced political instability and sanctions affecting the supply of oil. Now, the assets in Sudan and Russia are facing challenges.





Will talk to those opposing Ratnagiri project, says Maharashtra Minister after meeting Sharad Pawar

A day after the Opposition Maha Vikas Aghadi (MVA) demanded the suspension of soil survey work for the multi-billion dollar Ratnagiri Refinery and Petrochemical Limited at Barsu in Ratnagiri district following protests by villagers, Maharashtra Industries Minister Uday Samant on Wednesday met Nationalist Congress Party (NCP) chief Sharad Pawar in Mumbai and briefed him about the situation.

Mr. Pawar said while

they did not oppose any project that was expected to benefit the people of the Konkan region, one could not ignore the intensity of locals' opposition to a particular project.

"It is important to understand why the locals are opposing and a need on the part of authorities to have a dialogue with them. If their demands are legitimate, then there is a need to find an alternative site for the project," Mr. Pawar said after meeting Mr. Samant.

Villagers are protesting against the project and the

MVA coalition is supporting them. Ratnagiri police have arrested 111 people, most of them women, during the protest. In February, Marathi newspaper journalist Shashikant Warishe was mowed down by an SUV allegedly driven by land broker Pandharinath Amberkar, a supporter of the project, while the victim was extensively reporting on the issues related to the setting up of the unit.

When asked about the Shinde-Fadnavis government's claims that it was Shiv Sena (UBT) leader Uddhav Thackeray who suggested Barsu as an alternative site for project instead of Nanar, when he was the Chief Minister, Mr. Pawar said he was not

aware of that.

Mr. Samant assured to hold dialogues with the locals on Thursday.

He also clarified that there was no survey being conducted at Barsu, and only soil testing was being conducted to know if the project could come up there.

"This is a very preliminary stage. The government will speak to the villagers. We are in favour of having dialogue," he said.

Meanwhile, Shiv Sena (UBT) has decided to launch an agitation against the proposed project.

कोयला परतों से मिथेन निकालने की परियोजना में 2,000 करोड़ का और निवेश करेगी एस्सार

निजी क्षेत्र की तेल, गैस खोज और उत्पादन कंपनी एस्सार ऑयल एंड गैस एक्सप्लोरेशन एंड प्रोडक्शन लि. (ईओजीईपीएल) पश्चिम बंगाल के रानीगंज में कोयले की परतों में पाई जाने वाली मिथेन गैस (सीबीएम) परियोजना में अगले डेढ़ से दो साल में 2,000 करोड़ रुपए का और निवेश करेगी। कंपनी इससे पहले रानीगंज ब्लॉक में 5,000 करोड़ रुपए का निवेश कर चुकी है। इसके तहत कंपनी ने 350 कुओं की खुदाई की और वह प्रतिदिन नौ लाख घन मीटर गैस का उत्पादन कर रही है। ईओजीईपीएल के मुख्य कार्यपालक अधिकारी (सीईओ) पंकज कालरा



ने कहा कि 200 और कुओं की खुदाई के लिए अगले डेढ़ से दो साल में 2,000 करोड़ रुपए का अतिरिक्त निवेश किया जाएगा। उन्होंने कहा, हम मौजूदा कुओं से उत्पादन नौ लाख घन मीटर प्रतिदिन से 13 लाख घन मीटर प्रतिदिन करने के लिए अत्याधुनिक प्रौद्योगिकी का उपयोग कर रहे हैं। इसके अगले कुछ महीनों में परा हो जाने की उम्मीद है। कालरा

ने कहा कि अतिरिक्त कुओं से उत्पादन शुरू होने के साथ ग्रनीगंज से कोयला परतों से मिथेन उत्पादन तीन लाख घन मीटर प्रतिदिन पर पहुंचने का अनुमान है। उन्होंने कहा कि देश में कोयला खदानों से उत्पादित मिथेन में कंपनी की हिस्सेदारी फिलहाल 35 प्रतिशत है। अतिरिक्त कुओं की खुदाई से हिस्सेदारी बढ़कर 90 प्रतिशत तक हो जाने का अनुमान है।

पवार ने कहा कि उनकी पार्टी ने कोंकण में विकास परियोजनाओं का विरोध नहीं किया लेकिन स्थानीय लोगों के विचार जानना बेहद जरूरी है।पूर्व केंद्रीय मंत्री ने कहा, सरकार को
