

MNJPL project nears completion, says GAIL

NEW DELHI: GAIL (India) Limited is close to completing its ambitious Mumbai-Nagpur-Jharsuguda Pipeline (MNJPL) project, being developed as part of the National Gas Grid (NGG). The project has been identified as a high-impact initiative under the Centre's PM GatiShakti National Master Plan.

The 1,707-km pipeline traverses four states — Maharashtra, Madhya Pradesh, Chhattisgarh and Odisha — and is designed to enhance the supply of clean fuel across the region. Once operational, it will cater to the growing requirements of the City Gas Distribution (CGD) network and industrial consumers. The Petroleum and Natural Gas

Regulatory Board (PNGRB) has earmarked 17 Geographical Areas (GAs), covering 60 districts along the pipeline corridor, for gas distribution.

According to GAIL, pipeline construction has been fully completed in Chhattisgarh, Odisha and Madhya Pradesh. In Maharashtra, work is in its final phase, with only 11 km pending out of the total 1,707 km stretch. The company added that 1,440 km of the pipeline is already ready for gas-in.

GAIL anticipates the entire MNJPL project will be fully commissioned by December 31, 2025. The company's Board of Directors approved the timeline at a meeting held on Wednesday.

With ₹5,364 cr investment, GAIL to double LPG pipeline capacity

GAIL INDIA WILL invest ₹5,363.88 crore to double the capacity of its liquefied petroleum gas (LPG) pipeline to 6.5 million tonnes a year from its existing capacity of 3.25 million tonnes per year, the state-run company said in a stock exchange filing on Tuesday.

The pipeline, which runs from Jamnagar on the west

coast to Loni in Uttar Pradesh, is expected to complete its expansion by July 2028. Funding will be a mix of debt and equity, GAIL said.

In a separate filing, the company announced a delay in the completion of its Mumbai-Nagpur-Jharsuguda gas pipeline project. The revised completion date is now December 31, pushed back from the original September timeline.

Part-A of the Mumbai-Nagpur pipeline is mechanically

complete, pending final clearance from the Petroleum and Explosives Safety Organisation (PESO). The Nagpur-Jharsuguda segment is also mechanically complete and ready for gas-in.

The Maharashtra pipeline work of around 9 km is balance. The work is under progress and expected to be ready for Gas-in by December, 2025, Gail said. Maharashtra (62 km) pipeline work of around 1.8 km is balance and is expected to be completed by October, 2025.

Odisha. This natural gas pipeline will ensure availability of clean fuel and cater to the demands of CGD and the industrial sector. The Petroleum and Natural Gas Regulatory Board has also identified 17 Geographical Areas (GAs) covering 60 districts along this pipeline network. As of now, pipeline construction has been completed in the state of Chhattisgarh, Odisha, and Madhya Pradesh. In Maharashtra, project execution is in its final stages and only 11 km of pipeline construction is remaining out of a total 1,707 km of pipeline. Further, the 1,440 km of pipeline is ready for gas-in.
