

US-Nato's threat to Russian oil buyers masks a bid to check China and corner the arms market

# The Real West Side Story

ato secretary general Mark Rutte may have thought he would cause jitters in India, China and Russia if he spoke the strident language of Donald Trump. That he caused no disquiet was evident in the stock markets in India, China and the Western world.

Rutte 'ordered' India, Brazil and China—all BRICS members—to stop buying Russian oil after Trump threatened to punish them for non-compliance by imposing an additional 100% tariff. Curiously, he omitted mentioning Türkiye, a Nato member, being the third-biggest importer of Russian crude after India and China.

It is amazing that some of the best strategists in the Western world would come up with a simplistic solution for resolving the Ukraine crisis: provide Ukraine with top-notch weapons and weaken Russia by blocking oil exports. Choking distribution of Russian oil.

which accounts for 15% of global supply, would shoot up international crude prices, possibly by 20-30% from the present level of \$68 a barrel.

Markets were indifferent because they knew that European countries, and even the US, would not seriously commit themselves to such selfharm. Though the EU has moved away from Russian oil, it still purchases 19% of its natural gas requirements from Russia.

So, why should India, which saves more than \$11 bn a year by buying discounted Russian oil, accept this 'diktat', which is equal to an additional tariff? Indian officials prefer to wait. An earlier statement by S Jaishankar after US senator Lindsey Graham proposed a 500% tariff on buyers of

Russian oil is an indicator of New Delhi's thinking. 'So, we have been in touch with Senator Graham. Our concerns and our interests on energy security have been made conversant to him. So, we'll then have to cross that bridge when we come to it, if we come to it,' Jaishankar said earlier this month.



China has protested the move, while Russian leaders are literally joking about it. 'China believes dialogue and negotiation are the only viable solution to the Ukraine crisis. We categorically oppose all illegal unilateral sanctions and long-arm jurisdiction,' Chinese foreign ministry spokesperson Lin Jian said on Wednesday. 'Coercion and pressure cannot resolve fundamental issues.'

Trump, who consistently opposed high-spend support for Ukraine, and relied on his 'friendship' with Vladimir Putin to resolve the crisis, made a volte-face, offering top-notch military equipment to Kyiv. Some commentators have credited Rutte for bringing about this change by enticing Trump with promises of higher

sales of US-made military hardware.

But there is more to it. Trump, and a section of European leaders, have been looking for ways to keep Beijing under pressure as they find Chinese companies surging ahead of Western businesses in sales and innovation. Cutting off Russian oil supplies could be a good way to force China, the biggest oil buyer, to pay more while weakening a supposed India-Russia-China 'alliance'.

They are also hassled by the expansion and rising clout of BRICS, which Trump recently described as an 'anti-American' group. He takes the de-dollarisation threat more serious ly than some BRICS members like India. The fact that the Russian economy has survived nearly four years of, in Putin's words, a 'special military operation' is seen by many as a direct

affront to the supposed power of economic sanctions and Western plans to weaken

the nation. India and China are blamed in some quarters for Russia's endurance.

India is the second-biggest arms buyer in the world after Ukraine. Russia remains the largest arms supplier, meeting 36% of India's arms requiremeon the issue. According to Stockholm International Peace Research Institute (Sipri), 'India is shifting its arms supply relations towards Western suppliers, most notably France, Israel and the US.'

A key element in the growth of the defence industry is the existence of enemies and threat perception. Russia, China, Iran, North Korea and, to a smaller extent, India help to meet this requirement for Western defence manufacturers. Qatar and Saudi Arabia are the third- and fourth-biggest buyers, mainly because of the threat perception from Iran.

Trump recently said that his success in persuading European countries to spend 5% of their GDP on defence has thrown up a potential market of \$1 tn for the sector. It is obvious that American defence companies and politicians do not want China to start bidding for a piece of the new market by offering discounted rates. They don't want to share the fate of US construction and railroad companies, which failed to stop Chinese players from penetrating parts of Europe over the past decade-and-a-half.

They also want a share of the Indian defence market, even if it's necessary to ensure continued discord between Asian neighbours, India, Pakistan and China. Trump's repeated claims about ending the recent India-Pakistan conflict should be seen in this context.

So, the goals set out by the Trump-Nato combine cover several aspects other than oil.

They include countering China's influence, weakening BRICS and enlarging the market potential of Western arms producers. The question is whether it will succeed in bringing India closer to the West (read: the US). Or, make New Delhi and Beijing strange tactical bedfellows.

## Crude may Hit \$140 Per Barrel if Russia Supply is Cut: Puri

'India would guickly switch to alternative sources'

New Delhi: Oil minister Hardeep Singh Puri on Thursday warned that taking Russian supplies off the market could push oil prices to \$130-140 per barrel, detailing the potential impact of secondary sanctions, while adding that US President Do-nald Trump's tariff threats were not yet a cause for concern for India. "I'm not worried at all. If something happens, we'll deal with it," Puri told an industry gathering, referring to Trump's threat on Monday to impose secondary tariffs of 100% on countries that trade with Russia if Moscow fails to conclude a peace deal with Ukraine within 50 days.

Russia produces about 9 million barrels per day, or roughly 10% of global output and consumption, Puri said. Removing such large volumes would be difficult and require the world either to consume less or let prices soar, he added.

"There are two possibilities: one, the whole world consumes 10% less—which means some people won't get heating in winter; some won't get air conditioning in summer; some of the transport will stop flying," Puri said. "Or, you start buying more from the remaining 90% (suppliers). You know what that would do to prices? The prices would skyrocket," he added.

India would quickly switch to alternative sources to meet its oil demand if any supply were cut off, Purisaid, adding that the world is currently awash in oil, which is helping keep prices in check.

Oil prices will remain around \$65 per barrel over the next few months, Puri said.



"We will go back to pre-Ukraine days," said Indian Oil chairman A S Sahney, responding to how the nation's top refiner would cope with secondary tariffs on Russia. India sourced just 0.2% of its crude from Russia before Ukraine war. That share quickly rose to around a third of India's imports as western buyers shunned Russian oil. making it available at a discount to Indian refiners.

Puri also said the government was taking new measures to boost exploration and production in the country.

## 'Prepping for Euro VII Norms'

According to Gadkari, trials are being held in the ministry of petroleum and natural gas on Russian technology that can raise the calorific value of ethanol to match that of petrol. This will eventually make 100% ethanol viable in the country, he said.

Responding to a query on tightening emission norms, Gadkari said there had been much resistance when India decided to jump from BS-IV to BS-VI in 2020. "India's emission norms are comparable to the world. Now there is talk of Euro VII. We are preparing for it," he said.

Commenting on the ban on endof-life vehicles in the National Capital Region, Gadkari said, This should be addressed by taking a studied legal position on the issue," but added that converting a petrol or diesel vehicle into CNG makes economic sen-

He also said the Delhi government has the authority to make laws on the petrol-diesel vehicle ban, and take measures to address concerns regarding the legality of the move while keeping public health in mind.

The MoU was signed in the presence of Minister of Petroleum and Natural Gas Hardeep Singh Puri on the sidelines of Urja Varta 2025 event here. This is the first of the series of such initiatives which will be done. As part of the pact, ONGC will be putting in money and BP will provide expertise, said Pankaj Jain, secretary, petroleum ministry.— PTI



## 'India can secure oil from other sources if Russian imports are sanctioned'

Union Minister of Petroleum and Natural Gas Hardeep Puri on Thursday expressed strong confidence that India can meet its energy requirements from alternative sources if Russian supplies are impacted by secondary sanctions.

"I don't feel any pressure in my mind. India has diversified its sources of supply, and we have expanded from approximately 27 countries to around 40 countries now," he stated at the Urja Varta annual conference of the Directorate General of Hydrocarbons (DGH). Puri highlighted the emergence of new suppliers, such as Guyana, and noted that supplies could also be ramped up from existing producers Brazil and Canada.

Earlier this week, US President Donald Trump warned that countries purchasing Russian exports could face sanctions if Moscow fails to reach a peace agreement with Ukraine within 50 days. This threat comes amid ongoing legislative efforts in the US Congress.

Senators Lindsey Graham and Richard Blumenthal have introduced a bipartisan Bill, the Sanctioning Russia Act of 2025, which proposes imposing tariffs as high as 500 per cent on countries, including India and China, that continue to purchase Russian oil, gas or uranium.

This Bill has significant support from other lawmakers, and aims to exert strong economic pressure on Russia.

Puri also emphasised India's increasing exploration and production activities. "I'm not worried at all. If something happens, we'll deal with it," he affirmed.

Furthermore, he indicated that India has the scope to cut fuel prices if crude oil prices remain at current levels for the next two to three months. "The price of oil will come down as more sources of supplies are coming. We have enough oil around," said the Minister, highlighting India's proactive strategy in securing energy supplies from a wider range of countries.

Commenting on the threat of US' secondary sanctions against countries engaging with Russia, the Minister noted: "Russia accounts for 10 per cent of global production. Our analysis suggests that if Russia was not included, prices would have surged to \$130 a barrel. Even Turkey, China, Brazil, and even the EU, have bought oil and gas from Russia."

#### TOP SUPPLIER TO INDIA

India's oil imports from Russia increased marginally in the first half of this year, with private refiners – Reliance Industries Ltd and Nayara Energy – accounting for about half of the overall purchases from Moscow. Russia continued to be the top supplier to India, contributing approximately 35 per cent of India's overall supplies, followed by Iraq, Saudi Arabia, and the United Arab Emirates.



# ONGC inks MoU with bp for offshore drilling

STATE-OWNED OIL and Natural Gas Corporation (ONGC) on Thursday signed a strategic Memorandum of Understanding with bp to collaborate on drilling stratigraphic wells in India's Category II & III offshore sedimentary basins: Andaman, Mahanadi, Saurashtra, and Bengal.

This partnership will enhance geological understanding and unlock untapped hydrocarbon potential, strengthening India's long-term energy security, the company said. The MoU was signed in the presence of oil minister Hardeep Singh Puri, on the sidelines of Urja Varta 2025 reaffirming the government's commitment to deepen global collaboration in India's energy journey.

"We are excited to underpin our existing alliance with ONGC in this project of national and strategic significance. We



believe drilling of new stratigraphic wells will be very valuable and can lead to a new understanding and potential. Bp's experience in deep water exploration supported by new seismic technologies would be of great assistance during the evaluation and subsequent drilling of stratigraphic wells," said Kartikeya Dube, Head of Country, bp India.

Earlier, ONGC has also selected bp as the technical service provider for enhancement of its Mumbai High oil and gas field providing up to 60% increase in the production overbaseline levels.

# Puri hints at fuel price cut if crude is stable


OILMINISTER HARDEEP Singh Puri said on Thursday that the prices of petrol and diesel could be cut in the coming months if (crude) prices remained at current levels. "If things remainlike this, I think moving forward in the next quarter there is scope for reduction," he said.

Brent crude prices were hovering around \$68.96/bbl on Thursday. India has kept diesel and petrol prices unchanged since March 2024.

With Venezuelan crude already under US tariffs and Russian flows potentially facing similar restrictions, Indian refiners are likely to diversify oil supplies further primarily from the US, Brazil, West Africa, and the Middle East.

India's crude oil inflows from the US surged more than 50% in the first half of 2025, compared with the same period of 2024, while flows from Brazil rose 80% over the same period, as per data from the S&P Global HARDEEP SINGH PURI, OIL MINISTER

According to data from S&P Global Commodities at Sea, India imported 271,000 barrels per day of crudeoil from the US in the year's first half, up around 51% from 180,000 b/d imported in the same period in 2024.

India currently imports energy worth \$15 billion from the US and may increase it to \$25 billion.

India is also doubling down on domestic oil and gas exploration as it targets to reduce the country's dependency on energy imports. The government has opened up 2.57 lakh square kilometres— biggest ever—for bidding under the 10th round of the Open Acreage Licensing Policy (OALP). A total of 22 states are participating in the exploration drive.

"We had 3.5 million sqkm of sedimentary area. We've already opened up 1 million sq km, including previously declared no-go zones," Purisaid.

The government is also encouraging more private and global participation in the country's oil exploration drive by compensating technical partners for surveys and offering first right of refusal on finds.

## 50% crude buy pact to cement Aramco tie-ups

STATE-RUN ONGC AND BPCI, which are setting up refineries on the country's west and east coasts, respectively, in joint ventures with Saudi Aramco, may commit to buying at least 50% of the crude to be processed at these facilities from the West Asian kingdom, sources familiar with the matter told FE.

Saudi Aramco is likely to pick up 20% stake in each of the new refineries. India has already indicated that the two refineries would procure at least 50% of its crude requirement from Saudi Arabia for the next 15-20 years, the sources said. From India's perspective, committed supply of crude to the two refineries is essential, given global uncertainties and potential supply disruptions.

Though the details are still beingworked out, Aramco's initial investment in both units could be around ₹24,000 crore (around \$2.8 billion at the current exchange rate), including a debt component commensurate with the equity, sources said. The investments could later be jacked up to \$5 billion as Aramco is likely to increase its debt exposure in the two units.

The two refining facilities, each with a capacity to process 12 million tonne of crude annually, will be set up at a cost of roughly ₹1 lakh crore each.

However, Saudi Arabia has not accepted the demand by the Indian side for a waiver of the Asian premium on crude imports. Asian premium is the effective high price that Asian

# Aramco tie-ups...

SAUDI ARAB HAS been a reliable and stable oil supplier for India, even though its share in India's total oil imports has come down to around 14% from 20% due to a rise in imports from Russia in the last couple of years. All such imports are currently subjected to Asian premium. Aramco has been one of the major exporters of crude into the country for decades, and its downstream investments in the country are expected to cement the ties. ONGC, in partnership with Aramco, plans to set up a refinery in Gujarat, while BPCL will set up the refinery in Andhra Pradesh. Senior government officials described Aramco's willingness to invest in the ventures as a "big milestone" as India aims to set up a chain of newoil refineries and emerge as the leader in Asia in this line of business.



UNFAZED BY NATO secretary general Mark Rutte's blunt warning of "100% secondary sanctions,"the government on Thursday indicated it felt "no pressure "as faras purchase of oil from Russia or any other country of its choice was concerned. "We will buy from wherever we have to because the prime minister's commitment is to the Indian consumer," oil minister Hardeep Singh Puri said, without explicitly referring to Russia.

Separately, ministry of exter-nal affairs (MEA) spoke spers on Randhir Jaiswal said, "Let me reiterate that securing energy needs of our people is understandably an overriding priority for us. In this endeavour, we are guided by what is on offer in the markets, and by the prevailing global circumstances

India, which meets 85% of its crude oil requirements via



imports, has ramped up purchases of Russian crude since the Eurasian country's war with neighbouring Ukraine broke out in early 2022 (see chart). The discounted Russian oil helped the country control the forex

outgo for the key energy source. Rutte's latest statement was

directed not only at India but also China and Brazil, and was a reiteration of what US President Donald Trumphas often said in this regard. "My encourage-ment to these three countries (India, China and Brazil), particularly is: if you live now in Beijing, or in Delhi, or you are the

president of Brazil, you might want to take a look into this (importingoil from and trading with Russia), because this might

hit you very hard," Rutte said. When asked for a response, Jaiswal said, "We would particularly caution against any double standards on the matter."

## India dismisses NATO threat...

PURI SAID THE country has enough supply options to ensure uninterrupted fuel availability even in turbulent times.

Speaking at Urja Varta 2025 here, he noted that there are new players coming to the oil market which will likely bring crude pricesdown.

"Prices of oil will come down because there is more oil available in the market. Today, two major suppliers of crude oil are sanctioned. Will the sanctions remain forever? There is more oil coming to the market from the western hemisphere. Brazil, Guyana, Canada, all are non OPEC members. I'm not worried at all. If something happens, we will deal with it. If major suppliers of oil go off the market, you divert,"Puri added.

The US recently said it could impose 100% tariffs on Russia and "secondary tariffs" on countries importing its oil - mainly India and China - if Russia did-



n't agree to a deal to end the Ukraine war in 50 days.

Analysts, however, warn that the US's proposed secondary tariffon countries buying Russian oil could severely disrupt Indian supplies while also resulting in an increase in the country's oil import bill, as the countrywill lose its access to discounted barrels.

"Suppose Russian crude is priced out due to tariffs or tighter compliance risks, we anticipate a gradual but steady

reallocation towardWTI, Brazilian pre-salt barrels, and a resurgence in Middle Eastern term flows," Sumit Ritolia, lead research analyst, refining & modeling at Kpler had earlier

As per latest data from Petroleum Planning and Analysis Cell, the country's import bill during Apr-Jun FY26 declined by almost 19% on-year to \$30.6 billion owing to discounts on Russian oil.

Ritolia had highlighted that

if secondary tariffs are imposed and actuality is coming hard on Russian crude,India's oil import bill could rise significantly, potentiallyby\$3-6 perreplacement barrel, depending on origin. "This would impact refiner margins, retail fuel pricing unless mitigated via new term contracts or discounts," he had said.

Even with longer haul and shadow fleet reliance, Russian barrels remain \$3-8/bbl cheaper than Middle Eastern or US grades on a landed-cost basis. If tariffs are levied on Russian oil, India is highly likely to experience a rise in its overall oil import costs.

Puri noted that the country has significantly diversified its sources-buying oil from 40 countries now compared to 27 earlier-and is ready for any global supply disruption, includingahypotheticalclosure of the Strait of Hormuz.



# Petrobras likely to redirect oil to Asia

Brazilian state-run oil firm Petrobras may redirect the oil it sells to the United States, sending more to Asia and Pacific markets due to higher tariffs the US announced on Brazil, its chief executive told *Reuters* on Thursday.

Although oil and gas exports make up a hefty share of Brazil's exports to the United States, Petrobras CEO Magda Chambriard said it is not an essential market for the firm.

"It is not much that we export (to the US). In general, we are not very worried," she said in her first public comments about the 50% tariff US President Donald Trump announced last week.

The US is also unlikely to feel a major impact if Brazil ceases exports, as the South American country has supplied less than 3% of the oil the country has consumed so far in 2025, according to consultancy StoneX. REUTERS



## 'Not worried about US sanctions on Russia oil imports'

ndia is not worried about threats of US sanctions on countries that buy Russian oil as there is enough supply in the market, petroleum minister Hardeep Singh Puri said.

Addressing Urja Varta 2025, an annual upstream oil and gas conclave, Puri added that more oil would come in, easing prices further.

President Donald Trump recently said the US could impose 100% tariffs on Russia and "secondary tariffs" on countries importing its oil—mainly China and India—if Moscow didn't agree to a deal to end the Ukraine war in 50 days.

Responding to a question on India's likely measures in case of secondary sanctions, he said, "My my own view is the price of oil will come down. It will come down only because there is more oil available in the international market. There is more oil coming on the global market from the western hemisphere. I mean countries such as Brazil, Guyana and Canada. They're not even OPEC+members. I'm not worried at all. If something happens, we'll deal with it." He added that India felt "no pressure" and had enough supply options to ensure uninterrupted availability even in turbulent times.

Citing estimates, Singh said

Russian oil accounted for about 10% of global oil production and that if India and other countries didn't buy it at all, prices could shoot up to \$130-140 a barrel.

China and India are the largest importers of Russian oil. After the West sanctioned Russia and imposed price caps on its oil in 2022 over the invasion of Ukraine, India increased imports of Russian oil as the country offered steep discounts.

In February 2022, at the start of the Russia-Ukraine war, Russian oil comprised of 0.2% of India's oil imports. It has now increased to around 36%

India has maintained that its strategy for sourcing energy prioritises its national interest and that of Indian consumers. "We will buy from wherever we have to because the prime minister's commitment is to the Indian consumer," Puri said during the fireside chat.

The initiative is expected to generate employment and improve clean fuel access in the

The Prime Minister will also dedicate the Durgapur–Kolkata section of the Durgapur-Haldia Natural Gas Pipeline to the nation. The 132-km stretch, developed under the Pradhan Mantri Urja Gangaproject, cost more than Rs 1,190 crore and runs through the districts of Purba Bardhaman, Hooghly, and Nadia. It aims to deliver natural gas to thousands of homes and industries, creating jobs during both construction and operational phases.

In a push for cleaner energy, Mr Modi will dedicate Flue Gas Desulphurization (FGD) systems at the Durgapur Steel Thermal Power Station and Raghunathpur Thermal Power Station, developed by Damodar Valley Corpora-

tion. The pollution control systems, valued at over Rs 1,457 crore, are expected to reduce sulphur emissions and contribute to air quality improvement in the region. On the rail front, the doubling of the 36-km Purulia-Kotshila rail line in Purulia district, built at a cost of Rs 390 crore, will also be inaugurated. The project is aimed at enhancing connectivity between key industrial hubs including Jamshedpur, Bokaro, and Dhanbad with Ranchi and Kolkata, enabling smoother freight movement. Additionally, the Prime Minister will inaugurate two road over bridges (ROBs) at Topsi and Pandabeshwarin Paschim Bardhaman district. The ROBs, constructed under the Setu Bharatam programme at a combined cost of Rs 380 crore, are expected to decongest traffic and enhance safety by replacing railway level crossings.

## India buys oil from 40 nations, not worried by US rider on Russian oil: Hardeep Puri

Union Minister of Petroleum and Natural Gas Hardeep Singh Puri on Thursday said India has diversified its sources for buying oil in the global market, due to which the government is not "unduly worried" over any US crackdown on Russia's oil exports.

Speaking at the Urja Varta 2025, the minister said India currently buys oil from 40 nations, as compared to 27 countries in 2007, and the global market is well-supplied.

"There is a lot of oil available in the market. Iran and Venezuela are currently under sanctions. But are they going to be under sanctions forever? Many countries, including Brazil, Canada and others, are ramping up output. I am not unduly worried about supplies as of now. We have diversified our sources." Puri said.

The minister's statement came against the backdrop of US President Donald Trump announcing that secondary sanctions would be imposed on countries buying Russian oil.



On 15 July, Trump had threatened to impose serious trade restrictions on Russia unless a peace deal with Ukraine is reached within 50 days. Trump said US tariffs on Russian exports would be increased to 100 per cent, while also threatening to impose secondary sanctions on countries such as India and China that buy oil from Russia.

On Trump's threats, Puri said: "I have heard these threats. Some statements are made to ensure two disputants settle an issue."

Puri further stated that India's oil purchases from Moscow had played an important role in stabilising prices in the global market.

He said crude oil prices could have skyrocketed to \$130 per barrel in the absence of India-Russia oil trade when the Ukraine war began in 2022.

Prior to the Russia-Ukraine war, India used to buy a mere 0.2 per cent of its crude imports from Moscow. This, today, stands close to 40 per cent.

The minister said that Russian crude was always under a price cap of \$60 per barrel but never under sanctions. India continues to stay firm on its stance of not buying crude oil from a country which is under sanctions, said Puri.



## No worry over potential Russian oil disruption: Puri

ndia does not see any oil supply disruption if its Russian crude imports get impacted as the country has diverse sources of oil and enough supply is available in the market, Petroleum Minister Hardeep Singh Puri said Thursday.


The NATO chief's remarks come amid tariff uncertainties and global trade wars with the US and India's own trade with Russia, particularly oil imports. Weeks ago, there were concerns in India over a controversial Bill in the US that proposed 500 per cent tariffs on countries that continue to trade with Russia. More recently, US President Donald Trump also threatened "bit-

ing" secondary tariffs at the rate of 100 per cent on buyers of Russian exports unless there is a Russia-Ukraine peace deal within 50 days.

"I don't feel any pressure in my mind. India has diversified the sources of supply, I'm not worried at all. If something happens, we'll deal with it, there is sufficient supply available," Puri said.

The minister added that India in recent years has expanded its crude sourcing slate from 27 countries to around 40 countries.

In a firm response to Rutte's threat of secondary sanctions, India also cautioned against "double standards" on the matter and asserted that its energy procurement from Russia is based on national interests and market dynamics. "We have seen reports on the subject and are closely following the developments. Let me reiterate that securing energy needs of our people is understandably an overriding priority for us," external

affairs ministry spokesperson Randhir Jaiswal said at his weekly media briefing.

"In this endeavour, we are guided by what is on offer in

the markets, and by the prevailing global circumstances. We would particularly caution against any double standards on the matter," he said.

India and China are the top importers of Russian crude, and New Delhi is engaging with US lawmakers and the Trump administration to raise concerns regarding the country's energy security.

New Delhi depends on imports to meet around 88 per cent of its crude oil needs, and Russia has been the mainstay of India's oil imports for nearly three years now. Russia currently accounts for around 40 per cent of India's total oil imports. Puri said that the massive market share of Russian crude in India's oil imports doesn't mean that New Delhi is dependent on Moscow for oil, and other suppliers can quickly come in to replace Russian volumes if there is any major disruption.

Slams NATO's double standards as many nations still relying on Moscow crude

Amid the US threat to impose "secondary sanctions" on Russian crude oil, India on Thursday said it was confident of meeting its energy requirements from alternative sources.

Oil Minister Hardeep Singh Puri said the world's third largest oil importer should be able to deal with any problems with Russian imports by seeking supplies from other countries. "India has diversified the sources of supply," Puri said at an event.

India meets more than 85 per cent of its crude oil needs through imports, with Russia accounting for 42 per cent (2.08 million barrels per day) of it. The Russian crude is capped at \$60 a barrel, lower

than the prevailing international rate of \$80.


US President Donald Trump had on Tuesday announced 100 per cent secondary tariffs targeting Russian trade partners if Moscow did not resolve its war with Ukraine in 50 days.

NATO Secretary General Mark Rutte also echoed Thump, saying India, Brazil and China could be hit "very hard" by the secondary sanctions if these countries continued to do business with Russia.

At his weekly media briefing, Ministry of External Affairs spokesperson Randhir Jaiswal said it was the government's priority to secure the energy needs of its people. He said India would pursue the "best offer available" to meet its needs.

New Delhi also cautioned against "double standards" in the enforcement of sanctions. The MoU was signed in the presence of Union Ministry of Petroleum and Natural Gas Hardeep Singh Puri on the sidelines of Urja Varta 2025 event in the national capital.

Pankaj Jain, Secretary, Min-

istry of Petroleum and Natural Gas, said this was one of the initiatives that "we have been talking about sometime ... called stratigraphic wells."

This is the first of the series of such initiatives which will be done. ONGC has taken the leap to tie up with BP in terms of well design, well location, understanding geology etc. As part of the agreement, ONGC will be putting in money, BP will provide expertise, he said.

In a statement, Kartikeya Dube, Head of Country, bp India, and Senior Vice President, bp group, said: "We believe drilling of new stratigraphic wells will be very valuable and can lead to a new understanding and potential. bp's experience in deep water exploration supported by new seismic technologies would be of great assistance during the evaluation and subsequent drilling of stratigraphic wells."

ountries that continue to trade with Russia. More recently, US President Trump also threatened "biting" secondary tariffs at the rate of 100 per cent on buyers of Russian exports unless there is a Russia-Ukraine peace deal within 50 days.

On the international front, Puri defended India's insistence on going ahead with crude oil imports from Russia despite Western criticism, in terms of both legality and national interest.

He said, "In February 2022, when the Russia-Ukraine war began, we were importing 0.2 per cent of our crude oil from Russia. Today, we have increased — yes — but our diversification has also increased. Now, we import from around 40 countries, whereas in the past it was 27."

Replying to the critics who advise against buying Russian oil, Puri remarked, "Some said — do not buy Russian oil. But I ask — is it sanctioned? No, it's not. Not for us. So why should we not buy from wherever we can, especially if it is good for the Indian consumer?" He added with conviction, "I do not feel any pressure."

The minister again reasserted that consumer-first is the guiding philosophy behind India's oil import policy. "The Prime Minister has been clear as daylight — our commitment is to the Indian consumer. We will do whatever is required to safeguard their interest and provide energy availability at the best possible prices," he stated.

The oil and gas sector in India is currently experiencing a significant transformation marked by bold policy initiatives, increased exploration activities, and a clear movement towards enhancing energy security and diversification.

The minister articulated a forward-thinking vision during a conclave attended by industry leaders and stakeholders in the national capital, prioritising national interest and consumer welfare in the decision-making process, thereby challenging traditional paradigms.

One of the biggest pluses in the minister's statement was the ninth round of the Open Acreage Licensing Policy (OALP), its success. He announced that "38 per cent of the bids received came from a one million square kilometre area that was previously considered a 'nogo' zone," referring to areas that had long been off-limits because of defence and strategic activities by the Indian Navy, Coast Guard, or DRDO.

Describing how these entrenched obstacles were removed, Puri added, "Earlier, if you wanted to conduct exploration, these agencies would use their influence and say this has to be a no-go area. But the Prime Minister made a bold decision. He said, 'You are doing excellent work, but I am still giving a million square kilometres for exploration.' That has changed the game."

This policy shift has already resulted in a major spike in activity. ONGC has drilled 578 wells during the current year, a record high in almost four decades. "The CMD ONGC has drilled more wells this year than likely in the last 37 years altogether," Puri said, highlighting the record scale of investment. "Just consider — it takes a \$100 million offshore well and a \$4 million onshore well. This is no small investment."

The minister attributed some of this pace to a leadership strategy shift at the core of public sector initiatives. "Before, oil company CMDs used to come for four-and-a-half months or six months. What strategic calls can they possibly make?" he wondered. "Now, we're making appointments for the complete 10-year term. They are taking long-term calls, putting money into exploration and production — and it's paying dividends."

The minister also referred to the reform of the law introduced by the Offshore Areas Mineral (Development and Regulation) Amendment Act (ORD Act). He referred to the pre-existing legal regime, which was from 1948, as antiquated. "Be it a mine in Odisha or a petroleum lease in the Andamans, the same law used to apply. Mining acquired a new law in 1976, but the oil industry remained saddled with the 1948 Act. The ORD Act is a paradigm shift," he added.



# Fuel prices may fall next qtr if global crude remains stable

PETROLEUM minister Hardeep Singh Puri on Wednesday said oil marketing companies (OMCs) may reduce petrol and diesel prices in the next quarter if global crude oil prices remain around \$65 per barrel.

Speaking at the Urja Varta 2025 event organised by the Directorate General of Hydrocarbons, the minister said If things remain stable (crude price), there is a scope for reduction. "We are one of the a few countries in the world where prices have come down over the last three-and-a-half years... Now, the inventory I'm holding was bought at \$75 a barrel, a month ago. As this inventory gets consumed slowly, if prices remain at current levels, my short answer is yes," said the minister.

He stated that despite global conflicts — including those in Iran, Israel, Gaza, and elsewhere — which could have affected crude supply and prices,

the global oil market has remained largely stable. "In fact, even amid concerns that the Strait of Hormuz might be shut — a real possibility in a military scenario — the market didn't react in a way that caused prices to spiral," he said. Puri added that during recent ten-

# TTD and IOCL to build LPG storage plant in Tirumala

A new chapter in infrastructure development at Tirumala began on Thursday with the ground-breaking ceremony for an LPG storage facility. The project, a joint venture between Tirumala Tirupati Devasthanams (TTD) and Indian Oil Corporation Limited (IOCL), aims to cater to the growing energy needs of the temple town, including the preparation of its famed laddu prasadam and daily annadanam meals.

TTD Chairman B.R. Naidu shared the development through social media, stating, "For the future needs of TTD, we have laid the foundation stone for an LPG storage centre with a capacity of 45 metric tonnes on the Outer Ring Road in Tirumala"

IOCL has been a consistent supplier of LPG to TTD for the past two decades. A new agreement between the two entities will ensure uninterrupted supply for the next 30 years. The state-of-the-art facility, being built at an estimated cost of Rs.8.13 crore over 1.86 acres, is slated for completion within six months.

Highlighting the significance of the initiative, Naidu said, "This gas will be utilized primarily for the preparation of laddu prasadam and annaprasadam, which are central to the services offered to devotees visiting the temple."

In addition to the new LPG plant, IOCL is already constructing a bio-gas facility near the Tirumala dumping yard. With an investment of Rs.12.05 crore, the plant will process 40 tonnes of organic waste daily, out of the 55 tonnes, generated into 1,000 kilograms of bio-gas, contributing to Tirumala's sustainability efforts.

TTD Executive Officer Satyanarayana, Executive Engineer Subrahmanyam, Deputy Engineer Chandrasekhar, along with other senior officials from TTD and IOCL, participated in the ceremony.

# PNGRB asks city gas firms to supply piped gas to all households at uniform rate

HYDERABAD

The Petroleum and Natural Gas Regulatory Board (PNGRB) directed city gas distribution (CGD) entities to supply piped natural gas at a uniform rate to all domestic household consumers, irrespective of daily consumption levels.

The oil regulator said this while taking note of a telescopic pricing structure for the gas supply to domestic consumers that certain CGD entities were implementing in which the per standard cubic metre (SCM) price of the commodity escalated as consumption crossed a predefined threshold.



The directive comes in context of a telescopic pricing by CGDs.

"Such pricing practices may inadvertently facilitate unauthorised use of subsidised APM (administered pricing mechanism) gas by commercial consumers who may be misclassified as domestic consumers. Additionally, genuine domestic consum-

ers with higher consumption levels may be unfairly subjected to elevated charges, despite natural gas being supplied to CGD entities at a uniform APM rate," PNGRB said.

## Thorough review

It advised CGD firms to undertake a 'thorough review of consumption patterns and investigate anomalous cases where domestic consumers exhibit significantly higher usage relative to industry average and take corrective measures.

It also cited government norms where natural gas is allocated at concessional rates to boost its adoption by households and the transport sector.

## **Fuel Folly**

Washington's new tariff plan for those who buy Russian oil is hypocritical & will hurt US too

After insulting Zelenskyy in Feb, pausing intelligence sharing with Kyiv in March, and weapons supplies in March and May, Trump finally has a plan to stop Putin. He's going to hit Russia and its trade partners with "very serious tariffs". Not immediately – Putin gets 50 days to finish the business he started in 2022. But as a big buyer of Russian oil, India should take note. Trump's threatened to impose 100% tariff on countries that buy Russian goods after the expiry of his deadline, and if he doesn't waver, or forget – neither unlikely – the concessions won through a trade deal could be lost.

Will tariffs work? Not directly, because Russia and US have never been more decoupled economically since the collapse of Soviet Union. US bought goods worth just \$3bn from Russia last year, and sold \$500mn worth, down from \$29bn and \$6bn, respectively, before the start of the war in 2022. That's why Putin must be checkmated

through secondary tariffs on his major oil buyers like China, India and Brazil.



Fossil fuels are a very big part of Russia's GDP (16%), and make up over half of its exports (55%). By the third anniversary of the war, Russia had earned about \$1tn from fossil fuel exports. India, which used to buy just 1% of its oil from Russia before the war, now sources 40%, so the threat of 100% tariff on exports could make it pivot again. And China, which buys 20% of its oil from

Russia, might also find 100% tariff discouraging.

Russia could be hurt, but at what cost? Plugging the Russian pipeline is bound to drive up oil prices, which could increase inflation in most places, including US. Add to that the US-specific price rise resulting from 100% tariff on China, India and other US trade partners, and the political risk might be too much for Trump's Republicans.

Above all, Trump's threat—backed by Nato secretary-general Mark Rutte—smacks of hypocrisy. After ordering the world not to buy Russian oil, US continued buying enriched uranium from Russia for its nuclear plants. Even when it announced a ban on Russian uranium imports from 2027, it gave a waiver to its largest operator of reactors. Likewise, Rutte's Europe is still buying gas from Russia, and won't stop till the end of 2027. So, Trump and Rutte's threat is less about conviction than convenience. India must play by the same rule.

"In this endeavour, we are guided by what is there on offer in the markets, as also by the prevailing global circumstances. We would particularly caution against any double standards on the matter," he added. India has in the past too accused the West of having double standards on the issue, saying that European countries have themselves benefited

from importing Russian energy for prolonged periods.

Puri said India has built up "navigational resilience" by expanding the sourcing of oil from 40 countries against 27 countries earlier. "India has been clear that it will buy oil from wherever it has to. The prime minister's commitment, in the final analysis, is to the Indian consumer," he said.

In addition, Puri said, more oil was coming into the global market from countries such as Brazil, Guyana and Canada that are not members of the OPEC+ grouping. "If a major source goes off the market, you diversify. The current debate in the oil market is whether prices will be in the range of \$65-70 or \$60-65 (per barrel)," he said.

On purchase of Russian oil by Indian refiners, Puri argued that those barrels were currently subjected to a price cap of \$60 and "not sanctioned". "We are happy to buy below the price cap. Our companies float tenders as per their requirement and whoever supplies the cheapest, they buy it (from them)," he said.



## रूस से तेल खरीद पर भारत का नाटो प्रमुख को जवाब, दोहरे मानदंड न अपनाएं

नई दिली, प्रेट्ट : रूस के साथ संबंधों को लेकर नाटो महासचिव मार्क रूट की प्रतिबंधों की धमकी पर प्रतिक्रिया व्यक्त करते हुए भारत ने गुरुवार को इस मामले में दोहरे मानदंड नहीं अपनाने के लिए आगाह किया। साथ ही कहा कि भारत का रूस से तेल खरीद राष्ट्रीय हितों और बाजार की गतिशीलता पर आधारित है। रूट ने भारत, चीन और ब्राजील को चेतावनी दी थी कि अगर वे रूस से व्यापार जारी रखेंगे तो उन पर प्रतिबंधों का जबर्दस्त असर पड सकता है।

विदेश मंत्रालय के प्रवक्ता रणधीर जायसवाल ने अपनी साप्ताहिक मीडिया ब्रीफिंग में कहा, 'हमने इस विषय पर रिपोर्टे देखी हैं और घटनाक्रम पर बारीकी से नजर रख रहे हैं। मैं दोहराना चाहता हं कि हमारे लोगों की ऊर्जा जरूरतों को परा करना हमारी सर्वोच्च प्राथमिकता है। उन्होंने कहा, 'इस प्रयास में हम बाजार में उपलब्ध चीजों और मौजुदा वैश्विक परिस्थितियों के अनुसार काम करते हैं। हम इस मामले में किसी भी दोहरे मानदंड के प्रति विशेष रूप से आगाह करेंगे। अमेरिकी राष्ट्रपति डोनाल्ड टंप द्वारा रूसी निर्यात पर 100 प्रतिशत टैरिफ और मास्को के साथ व्यापारिक संबंध रखने वाले किसी भी देश पर शुल्क लगाने की धमकी के बारे में पूछे जाने पर जायसवाल ने कहा, 'हम इस संबंध में हो रहे घटनाक्रमों और टिप्पणियों पर करीब से नजर रख रहे हैं।'



## ओखला में गोबर से ऊर्जा उत्पादन की संभावना तलाश रही सरकार



दिल्ली सरकार डेयरी से निकलने वाले गोबर से ऊर्जा उत्पादन की संभावना तलाश रही है। वह ओखला लैंडफिल साइट पर निर्माण एवं विध्वंस (सी एंड डी) अपशिष्ट पुनर्चक्रण संयंत्र स्थापित करने की दिशा में भी काम कर रही है।

एक अधिकारी ने बृहस्पतिवार को यह जानकारी दी। अधिकारी ने बताया कि मुख्यमंत्री रेखा गुप्ता के साथ हाल ही में हुई बैठक में दिल्ली नगर निगम (एमसीडी) ने कचरे का स्थानीय स्तर पर और पर्यावरण अनुकूल तरीके से निपटान करने की अपनी योजना साझा की। उन्होंने बताया कि एक अहम पहल मदनपुर खादर में सक्रिय बायोगैस संयंत्र है, जहां डेयरी से निकलने वाले गोबर से ऊर्जा पैदा की



जाती है। अधिकारी के मुताबिक, इसके अलावा एमसीडी गोबर को नालियों में जाने से रोकने के लिए विशेष नालियां और निपटान टैंक बना रही है। उन्होंने बताया कि इस मॉडल को अन्य डेयरी कॉलोनियों में भी लागू करने के लिए लगभग 15 करोड़ रुपये की जरूरत है। एमसीडी के अधिकार क्षेत्र में आने वाली 11 अधिकृत डेयरी में से एक मदनपुर खादर में डेयरी मालिकों ने 10 टन प्रतिदिन (टीपीडी) क्षमता का बायोगैस संयंत्र स्थापित किया है। अधिकारी ने कहा, हनिगम नांगली डेयरी में एक प्रदुषण नियंत्रण परियोजना भी क्रियान्वित कर रहा है, जिसमें गोबर को निकास नाले में जाने से रोकने के लिए एक अलग नाले और गोबर-निपटान कक्ष का निर्माण शामिल है। इस पायलट परियोजना की अनुमानित लागत 1.7 करोड़ रुपये है। अन्य डेयरी कॉलोनियों में भी इस मॉडल को लाग् करने के लिए 15 करोड़ रुपये का प्रस्ताव पेश किया गया है ₹ उन्होंने बताया कि एक अन्य प्रमुख परियोजना ओखला लैंडफिल साइट पर एक नया निर्माण एवं विध्वंस अपशिष्ट पुनर्चक्रण संयंत्र स्थापित करना है।इस सविधा का मकसद रोजाना 1,000 टन निर्माण एवं विध्वंस अपशिष्ट का प्रसंस्करण करना है. जिससे दिल्ली में प्रतिदिन उत्पन्न होने वाले लगभग 5.500 से 6,000 टन निर्माण अपशिष्ट का निपटान हो सकेगा।





## भारत रूसी तेल पर अमेरिकी प्रतिबंध की आशंका से चिंतित नहीं

भारत ने रूस से कच्चे तेल की आपूर्ति पर अमेरिकी प्रतिबंध लगने की आशंका को ज्यादा महत्व न देते हए बहस्पतिवार को कहा कि उसे अपने तेल आयात की जरूरतों को वैकल्पिक स्रोतों से पुरा करने का भरोसा है। पेट्रोलियम एवं प्राकृतिक गैस मंत्री हरदीप सिंह पुरी ने कहा कि दुनिया का तीसरा सबसे बड़ा कच्चा तेल आयातक भारत, रूस से तेल की आपूर्ति में किसी भी तरह की बाधा से निपटने के लिए अन्य देशों से तेल खरीद सकता है। पुरी ने रूस पर संभावित अमेरिकी प्रतिबंधों के प्रभाव को लेकर पूछे गए सवाल पर कहा, 'मेरे दिमाग में इसे लेकर किसी तरह का दबाव नहीं है। भारत के तेल आपूर्ति के स्रोतों में अब विविधता आ

चुकी है। हम पहले 27 देशों से तेल खरीदते थे, अब यह संख्या बढ़कर लगभग 40 हो गई है।'

वह हाइड्रोकार्बन महानिदेशालय (डीजीएच) की तरफ से आयोजित वार्षिक सम्मेलन ऊर्जा वार्ता में शिरकत के लिए आए थे। भारत अपनी कच्चे तेल की जरूरत का 85 प्रतिशत से अधिक हिस्सा आयात से पूरी करता है। परंपरागत रूप से पश्चिम एशिया भारत का मुख्य तेल आपूर्तिकर्ता रहा है, लेकिन पिछले तीन वर्षों में रूस प्रमुख स्रोत के रूप में उभरकर सामने आया है। फरवरी, 2022 में यूक्रेन पर रूस के हमले के बाद पश्चिमी देशों ने रूसी तेल पर प्रतिबंध लगा दिया था। उस समय रूस



ने कच्चे तेल पर भारी छूट देनी शुरू कर दी थी जिससे भारत जैसे देशों को बहुत फायदा हुआ। आज के समय में भारत के कुल कच्चा तेल आयात में रूस की हिस्सेदारी लगभग 40 प्रतिशत है।

पुरी ने कहा कि रूस के अलावा ब्राजील, कनाडा और गुयाना जैसे देशों से भी कच्चे तेल की आपूर्ति को बढ़ाया जा सकता है। अमेरिका के राष्ट्रपति डोनाल्ड ट्रंप ने हाल ही में चेतावनी दी है कि यदि रूस 50 दिन के भीतर युक्रेन के साथ शांति समझौते तक नहीं पहुंचता है तो रूस से आयात करने वाले देशों पर प्रतिबंध या उच्च शुल्क लगाए जा सकते हैं। पुरी ने कहा कि भारत घरेलू तेल खोज और उत्पादन को भी तेजी से बढ़ा रहा है। उन्होंने स्पष्ट रूप से कहा, 'मैं बिलकुल भी चिंतित नहीं हूं। अगर कुछ होता है तो हम उससे निपट लेंगे।'

इंडियन ऑयल कॉरपोरेशन के चेयरमैन ए एस साहनी ने कहा कि यदि रूस से तेल आपूर्ति बाधित होती है तो भारत यूक्रेन युद्ध से पहले लागू आपूर्ति व्यवस्था की ओर लौट सकता है। उस समय रूस से आयात दो प्रतिशत से भी कम था। पेट्रोलियम मंत्री ने बाद में एक संवाददाता सम्मेलन में कहा कि फिलहाल बाजार खासकर कीमतों के मामले में, किसी भू-राजनीतिक उठापटक पर प्रतिक्रिया नहीं देता है क्योंकि तेल की

अच्छी उपलब्धता है। पुरी ने कहा, 'वर्तमान में कच्चे तेल की कीमत लगभग 68.5 डॉलर प्रति बैरल है और आने वाले महीनों में भी इसके लगभग 65 डॉलर प्रति बैरल पर रहने की उम्मीद है।' उन्होंने बताया कि पेट्रोल में एथनॉल मिश्रण को 20 प्रतिशत के मौजूदा स्तर से बढ़ाने के लिए नीति आयोग के नेतृत्व में उद्योग के हितधारकों के साथ चर्चा और परामर्श जारी है। उन्होंने कहा कि सार्वजनिक क्षेत्र की कंपनी ओएनजीसी और ब्रिटेन की कंपनी बीपी ने कुएं के डिजाइन, उसके स्थान और भूगर्भीय समझ को लेकर साझेदारी की है।' इस परियोजना में ओएनजीसी निवेश करेगी जबकि बीपी अपनी तकनीकी विशेषज्ञता देगी। दोनों कंपनियां मिलकर अंडमान, महानदी और सौराष्ट-कच्छ जैसे क्षेत्रों में काम करेंगी।





## सस्ते हो सकते हैं पेट्रोल-डीजल: हरदीप पुरी

पेट्रोलियम मंत्री ने कहा– कच्चा तेल 65 डालर के आसपास रहने पर कीमतों में आ सकती है कमी

जागरण ब्यरो. नई दिल्ली: पेटोलियम और प्राकृतिक गैस मंत्री हरदीप सिंह परी ने कहा है कि अगर मौजुदा वैश्विक हालात ऐसे ही बने रहे और कच्चे तेल की कीमतें मौजुदा 65 डालर के आसपास बनी रहीं तो तीन-चार महीनों में देश में पेट्रोलियम उत्पादों की खुदरा कीमतों में कमी आ सकती है। देश में हाइड्रोकार्बन क्षेत्र पर आयोजित सबसे बड़े सेमिनार 'ऊर्जा वार्ता-2025' को संबोधित करते हुए पुरी ने कहा, 'सरकारी क्षेत्र की सभी तेल कंपनियों के पास 21 दिनों का भंडार है।' बुधवार को अंतरराष्ट्रीय बाजार में पेटोलियम उत्पादों की कीमत 67 डालर प्रति बैरल रहीं। वैश्विक स्तर पर भारी अनिश्चितता के बावजुद भारत में कमोवेश पिछले साढ़े तीन वर्षों में पेट्रोल, डीजल की खुदरा कीमतें स्थिर रही हैं।

पेट्रोलियम मंत्री ने अमेरिका की तरफ से भारत पर रूस से तेल खरीदने के बढ़ते दबाव को

अंतरराष्ट्रीय बाजार में भी कच्चे तेल के पर्याप्त विक्रेता है और भारत के पास पर्याप्त तेल भंडार भी है। भारत अपनी जरूरत का 85 प्रतिशत से ज्यादा कच्चा तेल आयात करता है और इसे रिफाइनरियों में पेटोल

और डीजल जैसे ईंधन में बदला

जाता है। परंपरागत तौर पर पश्चिम एशिया मुख्य स्त्रोता था, लेकिन रूस लगभग तीन सालों से मुख्य आपूर्तिकर्ता बना हुआ है। फरवरी, 2022 में मास्को द्वारा यूक्रेन पर आक्रमण के बाद पश्चिम के अधिकांश देशों ने रूसी कच्चे तेल से दूरी बना ली। रूस ने वैकल्पिक खरीदारों को आकर्षित करने के लिए भारी छूट की पेशकश शुरू कर दी। भारतीय रिफाइनिंग कंपनियों ने इस अवसर का फायदा उठाया और रूस भारत का सबसे बड़ा कच्चा तेल का आपूर्तिकर्ता बन गया।

## रूसी उत्पादन रोका तो महंगा होगा कच्चा तेल

पुरी ने कहा कि आज रूस दुनिया के सबसे बड़े तेल उत्पादक देशों में है। वह 90 लाख बैरल प्रतिदिन तेल का उत्पादन कर रहा है। जबिक वैष्ठिक उत्पादन तकरीबन 9.7 करोड़ बैरल प्रतिदिन का है। ऐसे में रूसी उत्पादन को रोका गया तो अंतरराष्ट्रीय बाजार में क्रूड की कीमत 130–200 डालर प्रति बैरल तक जा सकती है।

### फिलहाल 40 देशों से खरीद रहे कच्चा तेल

पेट्रोलियम मंत्री ने कहा कि वैश्विक बाज़ार में तेल की कोई कमी नहीं है। कई नए तेल विक्रेता आ गए हैं। गुयाना, अर्जेंटीना, ब्राजील जैसे गैर-पारपरिक देशों से भारत ज्यादा तेल की खरीद कर रहा है। अब हम करीब 40 देशों से तेल खरीद रहे हैं। पिछले छह महीने में वैश्विक स्तर पर काफी ज्यादा अस्थिरता होने के बावजूद कीमतों में बहुत ज्यादा बदलाव नहीं हुआ। मुझे लगता है कि आने वाले समय में कीमतें 65-70 डालर प्रति बैरल के बीच में ही रहेंगी।



## आपत्तिःभारत बोला, तेल पर नाटो का दबाव नहीं चलेगा



■ NBT रिपोर्ट, नई दिल्ली : पेट्रोलियम एंड नेचरल गैस मिनिस्टर हरदीप सिंह पुरी ने गुरुवार को कहा कि मौजूदा हालात को देखते हुए आने वाली तिमाही में क्रूड ऑयल का अंतरराष्ट्रीय भाव 65 डॉलर के आसपास रह सकता है। अगर यही स्थिति बनी रही तो पेट्रोल-डीजल के दाम घट सकते हैं।

हरदीप सिंह पुरी तेल के दाम आने

डायरेक्टरेट ऑफ हाइड्रोकार्बस की ओर से आयोजित ऊर्जा वार्ता कार्यक्रम के दौरान पुरी ने कहा, 'आज क्रूड प्राइस 68.5 डॉलर प्रति बैरल है। कच्चे

वाले समय में इसी रेंज में रहने की संभावना है। अगले 3 से 5 महीनों में यह 65 से 70 डॉलर के बीच रहेगा। अगर इसमें चेंज आता भी है तो 70 से ऊपर नहीं होगा, 65 से नीचे आएगा।'

पेट्रोल-डीजल की कीमतों के बारे में पूछे जाने पर उन्होंने कहा, 'हम चुनिंदा देशों में से हैं, जहां पिछले साढ़े 3 सालों में दाम घटे हैं। अगर क्रूड प्राइस इसी तरह बना रहा तो कंपनसेट किया जा सकता है। अगर यह 65 डॉलर के आसपास रहा, जिसकी संभावना है, तो आने वाली ऑयल मिनिस्टर हरदीप सिंह पुरी ने कहा, क्रूड ऑयल 65 डॉलर/बैरल के आसपास बना रहा तो बन सकता है चांस

तिमाही में दाम घटने का स्कोप हो सकता है। मुझे लगता है कि आने वाले 2 से 3 महीनों में इसका स्कोप है।'

पुरी ने रूस से क्रूड ऑयल खरीदने वाले देशों पर अमेरिका की ओर से प्रतिबंध लगाए जाने और उन पर टैरिफ बढ़ाए जा सकने की चेतावनी के बारे में कहा कि भारत इसको लेकर चिंतित नहीं है और अपनी जरूरत पुरी करने के लिए इसके पास दूसरे सोर्स भी हैं। पुरी ने कहा, 'मझे कोई दबाव महसस नहीं हो रहा। भारत अब कई जगहों से तेल खरीद रहा है। अगर कुछ होता भी है तो हम उससे निपट लेंगे। पहले जहां करीब 27 देशों से तेल खरीदा जा रहा था, वहीं अब 40 देशों से तेल ले रहे हैं।' रूस-युक्रेन युद्ध शुरू होने के बाद पश्चिमी देशों ने यह प्रतिबंध लगाया था कि रूसी तेल 60 डॉलर प्रति बैरल से ज्यादा पर कोई भी देश नहीं लेगा और अगर वह इससे ज्यादा पर लेगा तो उसकी शिपिंग कंपनियों को बीमा कवर नहीं दिया जाएगा।
