Candidate is required to submit enclosed Application Form duly filled in by him in his own handwriting and duly affixing a passport size colour photograph (a copy of the same photograph which was affixed by him on his e-application), 01 passport size photograph along with all ORIGINAL DOCUMENTS (in order as mentioned below from (i) to (vi) in respect of the following together with ONE SEPARATE SET OF PHOTO COPY of all documents duly SELF ATTESTED (in the same order) for verification at our end.
