Sl. No.	Query	Reply
1.	I am currently in the final year of B.E (Mechanical) course. Am I eligible to apply for the post of Executive Trainee (Mechanical)?	Candidates currently in final year (2016-17) of their Engineering Degree Course may also apply provided candidates belonging to General and OBC (NCL) category have secured minimum 65 % marks in aggregate and candidates belonging to SC/ ST/ PWD category have secured minimum 60 % marks in aggregate up to the last semester examination at the time of applying. Please refer to clause number 2.4 of the detailed advertisement in GAIL Website www.gailonline.com .
2.	I am having B.E/ B. Tech. degree in Metallurgy and have also applied for GATE – 2017. But this discipline /branch has not been advertised. Can I apply against the post of Executive Trainee (Mechanical)?	We regret that for the post of Executive Trainee (Mechanical), candidates with Graduate Engineering degree in Metallurgy are not eligible.
3.	I am having B.E/ B. Tech. degree in Production & Industrial Engineering and I have also applied for GATE – 2017 in Production & Industrial Engineering paper. Am I eligible to apply against the post of Executive Trainee (Mechanical)?	Engineering Graduates in Production & Industrial Engineering are eligible to apply against Mechanical discipline in GAIL, provided such candidates take GATE – 2017 examination in Mechanical Engineering Paper only.
4.	I am having B.E./ B. Tech. degree in Automobile. But this branch has not been specified in the detailed advertisement. Can I apply against the Post of Executive Trainee (Mechanical)?	We regret that for the post of Executive Trainee (Mechanical), Engineering Graduates in Automobile branch are not eligible.
5.	I am having B.E./ B. Tech. degree in Electronics & Communication. But this branch/ discipline has not been specified in the detailed advertisement for the post of Executive Trainee (Instrumentation). Can I apply against the post of Executive Trainee (Instrumentation) in GAIL?	We regret that for the post of Executive Trainee (Instrumentation), Engineering Graduates in Electronics & Communication branch are not eligible.

6.	I am having B.E./ B. Tech. degree in a branch/ discipline, which has not been specified in the detailed advertisement. Can I apply for the post of Executive Trainee in any Engineering Discipline?	NO. Candidates having engineering degree in a branch other than the branch/ discipline specified in the detailed advertisement are not eligible to apply for the post of Executive Trainee in engineering discipline.
7.	Can a candidate having done AMIE apply for the post of Executive Trainee in engineering discipline?	For the post of Executive Trainee in engineering discipline, qualifications prescribed stipulate full-time regular Engineering Degree i.e. B.E./ B. Tech./ B.Sc. Engineering from a recognized University/Institute. In view of this, AMIE qualification does not fulfill our requirement and as such, candidates having AMIE qualifications are not eligible to apply.
8.	I am not sure about the recognition of my engineering degree, can I apply?	As specified in the detailed advertisement, qualifications must be acquired from UGC recognized Indian University/ UGC recognized Indian Deemed University or AICTE approved courses from Autonomous Indian Institutions/ concerned statutory council (wherever applicable).
9.	I have 65 % marks in final semester of B.E (Mechanical). Can I apply for the post of Executive Trainee (Mechanical)?	Minimum percentage of marks in the essential qualification (s), as specified shall be considered as per Institute/ University rules/ norms.
10.	Is there any relaxation in the percentage of marks in Education Qualifications?	Relaxation in minimum percentage of marks in essential qualification will be provided in respect of SC, ST and PWD category candidates applying against vacancies specifically reserved for the respective category. Wherever minimum percentage marks in essential qualification has been specified as 65 % , relaxed minimum percentage marks in essential qualification in respect of SC, ST and PWD category candidates is 60 % . SC, ST, PWD category candidates applying against unreserved (UR) posts shall be considered under general standard of merit and no relaxation in minimum qualifying percentage of marks in education qualification shall be available to them.
11.	In my graduate engineering degree course only CGPA/ GPA/ SGPA has been awarded in place of percentage of marks. Can I enter the grade in my application?	Candidates, who have been awarded CGPA/ GPA/ SGPA or letter grades, should convert the grades to %age and provide only the equivalent percentage of marks in the application form. Minimum percentage of marks in the essential qualification (s), as specified shall be considered as per Institute/ University rules/ norms.

12.	Does one have to pay separate application fee for applying against the advertised posts of Executive Trainee in GAIL?	<p>NO. There is no separate application fee for applying against the advertised posts of Executive Trainee in GAIL. However, candidates need to pay the requisite fee for appearing in GATE – 2017.</p> <p>Details about GATE fees are mentioned in GATE – 2017 bulletin. Information about GATE is also available in website of 07 IITs – Bombay, Delhi, Guwahati, Kanpur, Kharagpur, Madras and Roorkee and also IISc, Bangalore.</p>
13.	I have appeared in GATE last year. Do I need to write GATE in this year again?	<p>YES. GATE – 2017 score is the only valid score for consideration for recruitment in GAIL for the year 2017. Scores from GATE – 2016 or prior to that will not be considered by GAIL for recruitment purpose.</p>
14.	GATE conducts its examination in so many papers. Will scores from all the papers be considered by GAIL?	<p>NO. GAIL will consider GATE – 2017 score in 06 engineering disciplines, which have been advertised. Please see the detailed advertisement in GAIL website www.gailonline.com.</p>
15.	Is there any upper age limit for appearing in GATE?	<p>As per information provided in the GATE-2017 official websites, there is no upper age limit for applying in GATE-2017 (please visit GATE-2017 official websites for confirming the same).</p> <p>However, for applying against the advertised posts of Executive Trainee in GAIL, candidates have to meet the upper age limit criteria as specified in the detailed advertisement. Please refer to clause number 4 of the detailed advertisement in GAIL Website www.gailonline.com.</p>
16.	Is there any minimum % of marks requirement for appearing in GATE?	<p>As per information provided in the GATE-2017 official websites, there is no minimum % of marks requirement for applying in GATE-2017 (please visit GATE-2017 official websites for confirming the same).</p> <p>However, for applying against the advertised posts of Executive Trainee in GAIL, candidates have to meet the minimum percentage of marks in essential qualification requirement as specified in the detailed advertisement. 17.	Are there any physical fitness criteria for appearing in GATE-2017? However, appointment to the advertised posts of Executive Trainee in GAIL will be subject to the candidate being medically fit as per the standards prescribed for the post by GAIL. If I want to change my GATE-2017 examination venue or want to correct a mistake in GATE-2017 form or if I face difficulty in downloading my GATE admit card with registration number, whom should I get in touch with?	You have to get in touch with GATE-2017 authorities. GAIL does not have any control on conducting GATE-2017 examination. The procedure is enumerated in GATE – 2017 bulletin.
19.	Can I apply to GAIL after appearing the GATE – 2017 examination?	The relevant link for submission of application online by the candidates will be made available from 1100 hrs. on 10.01.2017 to 1800 hrs. on 17.02.2017 in the “Careers” Section of GAIL website: www.gailonline.com .
20.	Can I apply to GAIL before I download GATE-2017 admit card?	NO. GATE – 2017 admit card will have your GATE – 2017 Registration Number. You have to enter your GATE – 2017 Registration Number while applying in GAIL. Otherwise, we will not be able to retrieve your GATE – 2017 score.
21.	What is the procedure for applying Online for the advertised post of Executive Trainees in GAIL?	The detail modalities/ procedure/ instructions for applying online will be hosted in GAIL Website www.gailonline.com on 10.01.2017 .
22.	I am working in a Government/ Public Sector Company. Should I enclose an NOC/ Forwarding letter from my present employer at the time of applying for the Post?	Candidates presently employed in Central/ State Government departments, Central/ State PSUs or Semi Government organization must submit No Objection Certificate (NOC) from their present employer at the time of Group Discussion and/or Interview, if called for the same.
